Municipal Ordinance No. 29, S. 1980

AN ORDINANCE PROHIBITING THE SELLING AND PURCHASE OF ANIMAL MANURE THIS MUNICIPALITY AND THE TRANSFERRING OF ANIMAL MANURE OUTSIDE THE GEOGRAPHICAL JURISDICTION OF TIGBAUAN, ILOILO AND PROVIDING PENALTY FOR VIOLATION THEREOF.

SECONDED BY: Unanimously

SECTION 1 - This is Known as an Ordinance Prohibiting The Selling And Purchase Of Animal Manure This Municipality And The Transferring Of Animal Manure Outside The Geographical Jurisdiction Of Tigbauan, Iloilo And Providing Penalty For Violation Thereof.

- SECTION 2 Hereinafter no person shall sell or buy animal manure in the Municipality of Tigbauan, Iloilo.
- SECTION 2.1 No person shall transfer animal manure outside the geographical jurisdiction of the Municipality of Tigbauan, Iloilo.
- SECTION 3. Violators of this Ordinance shall be punished with a fine of fifty (P50.00) pesos or an imprisonment of five (5) days or both at the discretion of the honorable court.

SECTION 4 - This Municipal Ordinance shall take effect upon approval.
