Municipal Ordinance No. 35, S. 1980

AN ORDINANCE PROHIBITING MINORS FROM DRINKING INTOXICATING LIQUORS IN PUBLIC PLACES.

......

SPONSORED BY: Honorable Benjamin Taasan

SECONDED BY: Unanimously

SECTION 1 - This is Known as an Ordinance Prohibiting Minors From Drinking Intoxicating Liquors In Public Places.

- SECTION 2 Minors or youth below eighteen (18) years of age are prohibited to drink intoxicating liquors in public places.
- SECTION 2.1 Bar and store owners and likewise inhibited to serve and sell intoxicating liquors to minors below eighteen (18) years old in their establishments.
 - SECTION 3. Definition of Terms:
- SECTION 3.1 The term minors for purposes of this ordinance shall include those with the age of eighteen (18) years or below.
- SECTION 3.2 Intoxicating liquors include tuba, beer, wine and other alcoholic drinks which may cause inabrity when taken in excess.
- SECTION 3.3 Public places include public market, public plaza, streets, bars, stores and other places intended for public gathering and patronage.
- SECTION 4. Violators of the provisions of this Ordinance shall be punished with a fine of twenty (P20.00) pesos or an imprisonment of two (2) days or both at the discretion of the honorable court.
 - SECTION 4 This Municipal Ordinance shall take effect upon approval.
