Municipal Ordinance No. 2, S. 1981

AN ORDINANCE TO PENALIZE THE TAKING AWAY, CUTTING, TRAMPLING OR DESTROYING OF ORNAMENTALS IN THE PUBLIC PLAZA, THE PICKING OF MANGOES BY STONING OR BY ANY METHODS AND THE THROWING OF STONES ON THE ROOF OF THE STAGE OF THE PUBLIC PLAZA.

SPONSORED BY: Honorable Pedro Arias
SECONDED BY: Unanimously

SECTION 1 - This Is Known As An Ordinance To Penalize The Taking Away, Cutting, Trampling Or Destroying Of Ornamentals In The Public Plaza, The Picking Of Mangoes By Stoning Or By Any Methods And The Throwing Of Stones On The Roof Of The Stage Of The Public Plaza.

SECTION 2 - It is hereby prohibited to take away, cut, trample or destroy ornamental plants in the public plaza, pick mangoes by throwing stones or by any other method and the throwing of stones on the roof of the stage at the Public Plaza of this municipality.

SECTION 3. - Violators of this ordinance shall be penalized with a fine of twenty (P20.00) pesos or an imprisonment of two (2) days or both at the discretion of the Honorable Court.

SECTION 4. - This tax ordinance shall take effect upon approval.
