**Municipal Ordinance No. 4, S. 1981**

AN ORDINANCE IMPOSING PENALTY FOR “BANGUS” AND PRAWN FRY SMUGGLERS

SPONSORED BY: Honorable Jesus Ledesma, Chairman, Committee on Fisheries  
SECONDED BY: Unanimously

SECTION 1 - This Is Known As An Ordinance Imposing Penalty For “Bangus” And Prawn Fry Smugglers.

SECTION 2 - That as remuneration for the bid paid by the highest concessionaire of zone 6 or “bangus” or prawn fry area, all bangus ang prawn fry caught from said area shall be sold to the winning concessionaire or bidder at current price.

SECTION 2.1 - All “Bangus” or prawn fry sold to persons other than the authorized concessionaire (highest bidder of zone 6 during a public auction sale of fishing zones) shall be confiscated in favor of the Municipality and shall be sold by the latter to the former at current price.

SECTION 3. The bangus or prawn fry smuggler or smugglers shall pay a fine of two hundred (P200.00) pesos for every thousand of “bangus” or prawn fry smuggled or an imprisonment of twenty days or both fine and imprisonment at the discretion of the Honorable Court.

SECTION 4 - This Municipal Ordinance shall take effect upon approval.
