Municipal Ordinance No. 3, S. 1983

AN ORDINANCE AMENDING THE TRAFFIC PLAN OF THE MUNICIPALITY TO INSURE AN EASY FLOW OF  
VEHICULAR TRAFFIC DURING MARKET DAYS.

SPONSORED BY: Honorable Edmundo Perando  
SECONDED BY: Unanimously

SECTION 1 - This Is Known As An Ordinance Amending The Traffic Plan Of The Municipality To Insure  
An Easy Flow Of Vehicular Traffic During Market Days.

SECTION 2 - The amended traffic plan for vehicular traffic during market days only designates the  
following:

- A. As Parking Area for market cars and private cars:
  - 1. Tejero St. - (back of Tigbauan Elem. School)
  - 2. Allera St. - (beside Municipal Building) reserved for two market trucks
  - 3. Tejero St. - (fronting Dr. Teruel’s residence) reserved for three market trucks
  - 4. Allera St. - (beside brick walling between Sto. Niño-Minimart and Roman Catholic Convent)
  - 5. Allera St. - (beside Cristo Rey) reserved for vehicles of church goers
- B. Parking areas for PUJ’s:
  - 1. Tejero St. - (fronting Ogame’s Native Products) reserved for southbound jeepneys and cars
  - 2. Tejero St. - (fronting Zaara’s Store) reserved for northbound jeepneys and cars except those going to Iloilo City
  - 3. Corner Allera St. and Tejero St. - (fronting Gonzales’ residence and Twin’s Bakery) reserved for city bound vehicles
- C. Flow of traffic

1. Vehicles from Iloilo City and Northern Barangays of the Municipality traversing Tupas Street will pass in front of the Municipal Building, to Allera Street and exit at Leonardia Street and turn right to Tejero Street and turn left at the Pig Market and exit at Leonardia Street.
2. Vehicles coming from Guimbal and Southern municipalities and those plying the Dapdap route may pass the Roman Catholic Drive (back of church) and pass Trompeta Street (Agricultural products section) turn left at the Pig Market section and exit at Leonardia Street.
3. Vehicles coming from Guimbal and southern municipalities may pass Taldelore Street and turn right to Allera Street and exit thru Leonardia Street or may pass Taldelore Street and turn left to Trompeta Drive (Poultry and Agricultural Products market) turn left at Pig Market and exit through Leonardia Street.
4. Vehicles coming from Leon will pass in front of the Municipal Building and move down to Allera Street and turn right to Tejero Street and turn left to Trompeta Drive (Poultry and Agricultural Products Market and turn left passing the Pig market and exit thru Leonardia Street.

- D. No Loading or unloading signs - 6 meters from any intersection end:
1. Corner in fron of Caltex
  2. Corner of Tupas and Tejero Streets
  3. Corner of Tejero and Rivas Streets

SECTION 3. Non-compliance of this Ordinance imposes a fine of fifty (P50.00) pesos or an imprisonment or two days or both at the discretion of the Honorable Court.

SECTION 4 - This Municipal Ordinance shall take effect upon approval.
