Tax Ordinance No. 1, S. 1987

AN ORDINANCE TO LEVY AND TAX ON "TRISIKADS" OPERATING IN THIS MUNICIPALITY.

SPONSORED BY:           Honorable Celso Ledesma  
SECONDED BY:           Hon. Ramon Villa

SECTION 1 - This Is Known As An Ordinance To Levy And Tax On "Trisikads" Operating In This Municipality.

SECTION 2 - It is hereby provided that a "trisikad" operator shall pay a total of Fifty (P50.00) Pesos for fees and taxes broken down as follows:

Mayor's Permit .....	P20.00
Bicycle Fee.....	5.00
Sidecar License .....	20.00
Plate Number .....	<u>5.00</u>
<b>TOTAL .....</b>	<b>P50.00</b>

SECTION 3. - Violations of this Ordinance shall be punished by a penalty of a fine of Two hundred (P200.00) Pesos for the first time offenders; for second time offenders a penalty of a fine of Four Hundred (P400.00) and an imprisonment of not more than 1 day; and for third time offenders, confiscation of the "trisikads", a fine of not less than Five Hundred (P500.00) Pesos and an imprisonment of not more than three (3) days.

- a. First Offense - a fine of Two hundred (P200.00) Pesos
- b. Second Offense - a fine of Four Hundred (P400.00) and an imprisonment of not more than 1 day or both fine and imprisonment at the discretion of the Honorable Court.
- c. Third Offense - a fine of not less than Five Hundred (P500.00) Pesos and an

imprisonment of not more than three (3) days or both fine and imprisonment at the discretion of the Honorable Court..

SECTION 4 - This Tax Ordinance shall take effect upon approval.
