# Municipal Ordinance No. 4, S. 1987

A MUNICIPAL ORDINANCE BANNING TRICYCLES, PEDICABS (TRISIKADS), FROM PARKING IN NATIONAL HIGHWAYS.

SPONSORED BY: Honorable Ramon Villa, Committee on Finance SECONDED BY: Hon. Remedios Torrato, Chairman on Market

SECTION 1 - This Is Known As A Municipal Ordinance Banning Tricycles, Pedicabs or "Trisikads", From Parking In National Highways.

SECTION 2 - Specified parking areas for pedicabs on market days are as follows:

- a. Allera Street fronting Police Station
- b. Leonardia St. fronting Torrilla's Residence
- c. Tejero St. fronting de Paul eatery
- d. Tupan St. fronting Puericulture Center
- e. Santuyo St. fronting Aldon's Residence

SECTION 2.1 - Route of pedicabs shall be within the Poblacion only, not beyond ILECO, Tigbauan National High School and Sibalom Bridge.

SECTION 2.2 - Route of Tricycles is specified in Traffic Ordinance S. 1980.

SECTION 3. - Violations of this Ordinance shall be punished.

1<sup>st</sup> offense - fine of P100.00

2<sup>nd</sup> offense - a fine of P200.00 or an imprisonment of not more than one day or both fine

and imprisonment at the discretion of the Honorable Court

3<sup>rd</sup> offense - a fine of P300.00 or an imprisonment of not more than 3 days or both fine

and imprisonment at the discretion of the Honorable Court.

SECTION 4 - This Municipal Ordinance shall take e	ffect upon approval.
