Municipal Ordinance No. 92-007

AN ORDINANCE IMPOUNDING ALL STRAY DOGS ROAMING AROUND THE VICINITY WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF TIGBAUAN AND PROVIDING A PENALTY TO THE OWNERS THEREOF.

SECTION 1. All Dogs Roaming Around The Vicinity Within The Territorial Jurisdiction of the Municipality of Tigbauan, Iloilo shall be Impounded.

SECTION 2. Owners of Stray Dogs shall pay the penalty of not less than One Hundred (P100.00) Pesos.

SECTION 3. This Ordinance shall take effect upon approval.
