SECTION I. All construction firms or any other person engaging in the Sand and Gravel business and other quarry materials within the territorial jurisdiction of the Municipality of Tigbauan are prohibited to extract the same without a proper permit from the Provincial Governor.			
SECTION II. Any violator of this ordinance shall pay the penalty of not less than Five Hundred (P500.00) Pesos and an imprisonment of Two (2) days or both at the discretion of the Honorable Court.			
SECTION III. Materials extracted illegally shall be confiscated in favor of the Municipal Government of Tigbauan.			
SECTION IV. Vehicles used shall be impounded until the above-mentioned penalty shall be complied with.			
SECTION V. This Municipal Ordinance shall take effect upon approval.
