**Municipal Ordinance No. 92-009**

AN ORDINANCE TO PENALIZE THE TAKING AWAY, CUTTING, TRAMPLING OR DESTROYING OF ORNAMENTAL PLANTS IN THE PUBLIC PLAZA, THE PICKING OF MANGOES BY STONING OR BY ANY OTHER METHOD.

SECTION 1. This is Known As An Ordinance To Penalize The Taking Away, Cutting, Trampling Or Destroying Of Ornamental Plants In The Public Plaza, The Picking Of Mangoes By Stoning Or By Any Other Method.

SECTION 2. It is hereby prohibited to take away, cut, trample or destroy ornamental plants in the public plaza, pick mangoes by throwing stones or by any other method.

SECTION 3. Violators of this ordinance shall be penalized with a fine of thirty (P30.00) pesos or an imprisonment of three (3) days or both at the discretion of the Honorable Court.

SECTION 4. This ordinance shall take effect upon approval.
