Municipal Ordinance No. 93-001

AN ORDINANCE REQUIRING ALL MERCHANTS AND/OR VENDORS OF VARIOUS PRODUCTS LIKE MEAT, FISH, POULTRY FEEDS, CEREALS, HARDWARE, FRUITS AND VEGETABLE TO REGISTER THEIR SETS OF WEIGHTS OR MEASURES WITH THE MUNICIPAL TREASURER’S OFFICE THROUGH THE MARKET SUPERVISOR, THIS MUNICIPALITY.

SECTION 1. This is known As An Ordinance Requiring All Merchants And/Or Vendors Of Various Products Like Meat, Fish, Poultry Feeds, Cereals, Hardware, Fruits And Vegetable To Register Their Sets Of Weights Or Measures With The Municipal Treasurer’s Office Through The Market Supervisor, This Municipality.

SECTION 2. All Merchants or Vendors of various products like Meat, Fish, Poultry Feeds, Cereals, Hardware, Fruits and Vegetables are required to Register their Seats of Weights or Measures with the Office of the Municipal Treasurer through the market Supervisor of the Municipality upon the promulgation of this ordinance.

SECTION 3. Merchants or vendors who fail to comply with this Ordinance shall be meted a fine of one hundred (P100.00) Pesos.

SECTION 4. This ordinance shall take effect upon approval.
