Municipal Ordinance No. 93-003

AN ORDINANCE CREATING AND ORGANIZING A PEOPLE’S LAW ENFORCEMENT BOARD (PLEB) IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND FOR OTHER PURPOSES.

WHEREAS, Republic Act No. 6975 otherwise known as DILG Act of 1990 decrees the creation and organization by the Sangguniang Bayan in every Municipality such number of People’s Law Enforcement Board (PLEB) as may be necessary; NOW, THEREFORE:

BE IT ORDAINED, by the Municipal Council of the Municipality of Tigbauan, Province of Iloilo, as it is hereby ordained, that:

SECTION 1. Creation - There is hereby created and organized in the Municipality of Tigbauan, Province of Iloilo a People’s Law Enforcement Board (PLEB) pursuant to the provisions of Republic Act No. 6975 and Memorandum Circular No. 91-002 of the National Police Commission.

SECTION 2. Composition – The PLEB shall be composed of the following:

- a. Any member of the Municipal Council of Tigbauan chosen by a majority of the members thereof as embodied in a resolution to that effect.
- b. Any Barangay Captain in the municipality of Tigbauan chosen by the Association of Barangay Captains in a meeting to be held by them wherein this shall be in their Agenda.
- c. Three (3) other members who shall be chosen by the Peace and Order Council in a meeting to be held by them wherein this shall be in their agenda from among the respected residents of the Municipality of Tigbauan known for their probity and integrity, one (1) of

whom must be a member of the Integrated Bar of the Philippines, Iloilo Chapter or a lawyer, or a college graduate, or a Principal of the Central School in the locality.

The Chairman of the PLEB shall be elected from among its members.

SECTION 3. Term of Office - The term of office of the member of the PLEB shall be for a period of two (2) years from assumption of office. Said members shall hold office until their successors shall have been chosen and qualified.

SECTION 4. Compensation - Membership in the PLEB is a civic duty. However, PLEB members may be per diem as may be determined by the Municipal Council from municipal funds.

SECTION 5. General Provision - All other aspects regarding the PLEB in the Municipality of Tigbauan shall be governed by the provisions of RA. No. 6975 and Memorandum Circular No. 91-002 of the National Police Commission approved on April 8, 1991.

SECTION 6. Repealing Clause - All ordinances and resolutions inconsistent herewith are hereby considered repealed or modified accordingly.

SECTION 7. Separability Clause - In the event that any of the provisions of this ordinance is declared illegal, the validity of the other provisions shall not be affected by such declaration.

SECTION 8. Effectivity - This ordinance shall take effect ten (10) days after its approval and posted in two (2) conspicuous public accessible places.
