Municipal Ordinance No. 93-004

AN ORDINANCE AMENDING SECTION II OF THE MUNICIPAL ORDINANCE NO. 92-008, “AN ORDINANCE PROHIBITING THE EXTRACTION OF SAND, GRAVEL AND OTHER QUARRY MATERIALS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF TIGBAUAN WITHOUT A PROPER PERMIT FROM THE PROVINCIAL GOVERNOR.

WHEREAS, Section II of the Municipal Ordinance No. 92-008 states that “any violator of this ordinance shall pay the penalty of not less than Five Hundred (P500.00) Pesos and an imprisonment of two (2) days or both at the discretion of the Honorable Court”;

WHEREAS, the phrase in said penalty, “NOT LESS THAN Five Hundred (P500.00 Pesos” has not limit and is found out to be inconsistent to law;

WHEREAS, Article 100 (A) (III) of IRR, LGC of 1991 provides that the Sangguniang Bayan shall impose a fine of not exceeding Two Thousand Five Hundred (P2,500.00) Pesos and an imprisonment not exceeding six (6) months or both at the discretion of the Honorable Court;

NOW, THEREFORE, be it ordained, by the Sangguniang Bayan of Tigbauan, Province of Iloilo that:

SECTION 1 - This is known as an Ordinance Amending Section II of the Municipal Ordinance No. 92-008.

SECTION II - The amendment shall be, “Any violator of this Municipal Ordinance shall pay the fine of not less than Five Hundred (P500.00) Pesos and not more than Two Thousand Five Hundred (P2,500.00) Pesos and an imprisonment of not less than Five (5) days and not more than six (6) months or both at the discretion of the Honorable Court.

SECTION III - This Municipal Ordinance shall take effect ten (10) days after its approval and posting in two (2) conspicuous places.
