Municipal Ordinance No. 93-006

AN ORDINANCE PENALIZING ACTS OF VANDALISM AND OTHER MISCHIEFS IN ANY PUBLIC PLACES IN THE  
MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND PROVIDING PENALTIES IN VIOLATION THEREOF.

WHEREAS, it has become prevalent in the Municipality of Tigbauan the commission of various acts of  
vandalism especially in the comfort rooms, walls, public market, in the plaza or in any public places;

WHEREAS, the acts of vandalism have no place in our society and must be condemned in order to  
promote an orderly climate as a means of fostering peaceful social life of the municipality residents;

WHEREAS, those acts of vandalism have caused inconvenience on the viewers, sight sears, tourists as  
well as the lovers of a sanitary ecology and a consistent damage to public property and management;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Tigbauan, Province of Iloilo that:

SECTION 1 - It shall be unlawful for any person to commit acts of vandalism such as, but not limited to,  
slashing of seats by means of any bladed instrument, placing chewing gum or any other adhesive and  
obnoxious substances on the seats, destroying the seats through physical means, destroying comfort room  
fixtures, and other similar acts which will cause damage to school owners, government, or public properties  
and inconvenience to viewers, sightseers, tourists as well as to the lovers of a sanitary ecology and  
management.

SECTION 2. – Any person violating this ordinance shall be punished of a fine of One Hundred (P100.00)  
Pesos for the first offense or one day imprisonment, Three Hundred (P300.00) Pesos for the second offense or  
three (3) days imprisonment or both fine and imprisonment at the discretion of the court.

SECTION 1. - This ordinance shall take effect ten (10) days after its approval and posted in two (2) conspicuous public places in the Municipality of Tigbauan, Province of Iloilo as the Office of the Municipal Mayor may designate.
