Municipal Ordinance No. 94-004

AN ORDINANCE IMPOSING A FEE TO CONTRACTOR, PERSON, INDIVIDUAL, PARTNERSHIP, OR CORPORATION TO PRE-QUALIFY/PARTICIPATE IN THE BIDDING OF THE SUPPLY OF CONSTRUCTION MATERIALS, OFFICE SUPPLIES, OTHER RELATED FORMS OF SUPPLIES AND STRAIGHT BIDDING (ONE JOB SUPPLY OF MATERIALS PLUS LABOR) IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Section 447 (3) (1) of the Local Government Code of 1991, otherwise known as R.A. 7160, the Sangguniang Bayan is authorized to issue permits, fix and impose reasonable fees and charges for all services rendered by the Municipal Government to private persons or entities;

WHEREAS, the Municipality of Tigbauan, Province of Iloilo has not yet imposed any regulatory fees to Pre-qualified contractors and suppliers who are rendering services to this municipality;

WHEREAS, the Municipal Government of Tigbauan is in dire need of additional resources to augment the funds for the personnel, supplies and other miscellaneous expenses used for the purpose, and to finance program and projects relative to said services;

WHEREAS, the public hearing was conducted last July 8, 1994 and was attended by contractors, suppliers, concerned persons and the municipal officials, and they have no objection to this ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF TIGBAUAN, PROVINCE OF ILOILO THAT:

SECTION 1. Contractors, Persons, Individuals, Partnership, Or Corporations are required to secure permits and pay the corresponding fees and charges To Pre-Qualify/Participate In The Bidding Of The Supply Of Construction Materials, Office Supplies, Other Related Forms Of Supplies And Straight Bidding (One Job Supply Of Materials Plus Labor).

SECTION 2. The fees imposed are as follows:

- 1.) PERMIT TO PRE-QUALIFY/PARTICIPATE ON BIDDING IN THE SUPPLY OF CONSTRUCTION MATERIALS, OFFICE SUPPLIES, OTHER RELATED FORMS OF SUPPLIES AND STRAIGHT BIDDING (ONE JOB SUPPLY OF MATERIALS PLUS LABOR).
 - 1.1 P 50.00 - Annual Fee for the Supply of construction materials, office supplies and other related forms of supplies (Renewable Yearly)
 - 1.2 P200.00 - For Straight Contract (Annual Fee/Renewable Yearly)
- 2.) FOR THE ISSUANCE OF BIDDING TENDER DOCUMENTS/QUOTATION FORMS (For Supply of Construction Materials, Office Supplies and Other Related Forms of Supply)
 - 2.1 P 10.00 - For total cost quoted not exceeding P2,000.00
 - 2.2 P 20.00 - In excess of P2,000.00 of the total cost quoted but not exceeding P 50,000.00
 - 2.3 P 25.00 - For P50,000.00 up.
- 3.) FOR STRAIGHT CONTRACT
 - 3.1 P 10.00 - Of the total Bid Price but not exceeding P10,000.00
 - 3.2 P 20.00 - In excess of P10,000.00 but not exceeding P50,000.00
 - 3.3 P 25.00 - In excess of P50,000.00 but not exceeding P100,000.00
 - 3.4 P 30.00 - For P100,000.00 up.
- 4.) FOR SET OF PLANS (FOR STRAIGHT CONTRACT)
 - 4.1 P150.00 - For project not exceeding P50,000.00
 - 4.2 P250.00 - For project of P50,000.00 but not exceeding P100,000.00
 - 4.3 P500.00 - For project exceeding P100,000.00 but not exceeding P200,000.00
 - 4.4 P700.00 - For project exceeding P200,000.00 but not exceeding P500,000.00
 - 4.5 P1,200.00- For project exceeding P500,000.00 but not exceeding P1.0M
 - 4.6 P2,000.00- For project of P1.0M and up

SECTION 3. All contractors/suppliers with permit to pre-qualify/participate in the bidding of the supply of the construction materials, office supplies, other related forms of supplies and straight bidding shall be notified in accordance with the prevailing provisions of the Commission on Audit (COA), other existing laws and its implementing rules and regulations as amended.

SECTION 4. All ordinances and resolutions inconsistent herewith are hereby considered repealed or modified accordingly.

SECTION 5. In the event that any of the provisions of this ordinance is declared illegal, the validity of the other provisions shall not be affected by such declaration.

SECTION 6. This ordinance shall take effect ten (10) days after its approval and posted in two (2) conspicuous places in the public building for a minimum period of two (2) consecutive weeks.
