Municipal Ordinance No. 94-005

AN ORDINANCE AMENDING SECTION 3, THE PENAL CLAUSE OF MUNICIPAL ORDINANCE NO. 6, S. 1982, AN ORDINANCE PENALIZING ANY PERSON OR PERSONS FOR ACTS THAT WILL DIRECTLY OR INDIRECTLY CAUSE DAMAGE TO THE IRRIGATION FACILITIES OF THE SIBALOM RIVER IRRIGATION SYSTEM OR IN ANY MANNER CAUSE THE UNAUTHORIZED DISRUPTION, DIVERSION OR PREVENTION OF THE FLOW OF WATER FROM THE IRRIGATION CANAL TO THE IRRIGATED LOTS SCHEDULED FOR WATER DELIVERY.

WHEREAS, the Penal Clause (Sec. 3) of Municipal Ordinance No. 6, S. 1982 is already obsolete and needs to be amended accordingly so as to apply to present condition;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF TIGBAUAN, THAT:

SECTION 1. This is Known As An Ordinance Amending Section 3, The Penal Clause Of Municipal Ordinance No. 6, S. 1982, An Ordinance Penalizing Any Person Or Persons For Acts That Will Directly Or Indirectly Cause Damage To The Irrigation Facilities Of The Sibalom River Irrigation System Or In Any Manner Cause The Unauthorized Disruption, Diversion Or Prevention Of The Flow Of Water From The Irrigation Canal To The Irrigated Lots Scheduled For Water Delivery.

SECTION 2. Section 3 of Municipal Ordinance No. 6, S. 1982 is hereby amended to wit: Any person or persons who commit the offenses enumerated under Section 2 thereof (Municipal Ordinance No. 6, S. 1982) shall be punished with a fine of not less that P300.00 but not more than P1,000.00 or imprisonment of not less than fifteen (15) days or more than one (1) month at the discretion of the Honorable Court.

SECTION 3. This Municipal Ordinance shall take effect upon approval.
