Municipal Ordinance No. 95-001

AN ORDINANCE PROHIBITING ANY PERSON TO TAKE A BATH OR CAUSE TO BATHE ANIMALS AND OR WASH THE CLOTHES OR VEHICLES, THINGS AND OTHER WOVEN FABRICS IN THE PREMISES OF THE MUNICIPAL PLAZA OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the municipal government of Tigbauan, Iloilo has constructed wells and established water system in the municipal plaza purposely for the use in the maintenance of cleanliness, beautification, sanitation therein and watering of the plants for productive greening program of the government;

WHEREAS, it was observed by the Municipal Officials that our Tigbauan Plaza is being abused by other person(s) by using it as their bathing place and comfort, bathing of animals, washing of clothes, vehicles, things and other woven fabrics including utensils, thereby making it as an eyesore for the people and their remains had caused dirt to the surroundings;

WHEREAS, the public hearing (for the purpose of this ordinance) conducted on October 25, 1995 and was attended by municipal and Barangay officials and other concerned citizens showed positive reactions to push through said ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF TIGBAUAN, PROVINCE OF ILOILO THAT:

SECTION 1. Definition of Terms: The definition of terms as used in this ordinance:

- 1. PLAZA - is an open square of this municipality. In addition, its development includes cleanliness, beautification and sanitation. There shall be an establishment of planned sports facilities and other

infrastructure buildings; the place for holding some formal and informal programs and other activities relevant to entertainment and sports development of the government.

2. CLOTHES - are those woven fabrics of some fibrous materials used for covering the body and other garments used by human beings for self-comfort; a dress or bedclothes
3. VEHICLES - any kind of carriage or conveyance
4. THINGS - are those all kinds of fabrics woven by hands or machine regardless of sizes, thickness, width, classes and materials used

SECTION 2. It shall be unlawful for any person(s) to take a bath and or cause to bathe and or wash animals, the clothes or vehicles, things and other woven fabrics in the premises of the municipal plaza of Tigbauan, Iloilo, any time of the day of the year.

SECTION 3. Penalty Clause - Any person (s) found violating the provision of this ordinance shall be punished by:

1. First Offense - a written reprimand with copies to be furnished to parents (in the case of the children), to husband or children (in the case of a wife), wife or children (in the case of husband), or to employer (as the case maybe) to any of the above-mentioned.
2. Second Offense - a fine of P50.00 and to clean the surroundings
3. Third Offense - a fine of P100.00 and to clean the surroundings or an imprisonment of one (1) day or both at the discretion of the Honorable Court.

SECTION 4. REPEALING CLAUSE. Any ordinance or provision thereof inconsistent with any provision of this ordinance shall be deemed accordingly modified or repealed.

SECTION 5. SEPARABILITY CLAUSE. In the event any part or portion declared to be illegal, unconstitutional, or invalid, those parts or portions not affected thereby shall continue to be effective and enforceable.

SECTION 6. EFFECTIVITY CLAUSE. This Ordinance shall take effect ten (10) days after its approval, and posted in two (2) conspicuous places in the Municipality of Tigbauan, Province of Iloilo.

ENACTED. November 6, 1995.
