Municipal Ordinance No. 96-002

AN ORDINANCE IMPOSING A SOLEMNIZATION FEE OF ONE HUNDRED FIFTY (P150.00) PESOS ON MARRIAGES SOLEMNIZED BY THE MUNICIPAL MAYOR, MUNICIPALITY OF TIGBAUAN, ILOILO.

WHEREAS, pursuant to Section 444 (b) (I) (xviii) of Republic Act 7160, the Municipal Mayor, as the chief executive of the municipal government, shall "....solemnize marriage, any provision of the law to the contrary notwithstanding";

WHEREAS, the Municipal Civil Registrar (Mr. Eliseo Tuliva) of the Municipality of Tigbauan, has informed this body that almost all the municipalities in the Province of Iloilo are imposing solemnization fee on marriage solemnized by their respective Municipal Mayors;

WHEREAS, this body, after appropriate deliberation, deemed it wise and expedient to impose a solemnization fee P150.00 on marriages solemnized by the Municipal Mayor for the reason that the fee would certainly bolster our desire to increase the income of this LGU;

WHEREAS, in the public hearing called for the purpose, the Officers and Members of the Association of Barangay Captains (ABC), representing various sectors of the community, in their regular session interposed no objection to the proposal;

NOW, THEREFORE, on motion of Honorable Romeo Ledesma, duly seconded by Honorable Alfonso Babiera,

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION ASSEMBLED THAT:

SECTION 1. TITLE. This Ordinance Shall Be Known As "*An Ordinance Imposing A Solemnization Fee Of One Hundred Fifty (P150.00) Pesos On Marriages Solemnized By The Municipal Mayor*".

SECTION 2. An amount of ONE HUNDRED FIFTY (P150.00) PESOS shall be imposed on marriages solemnized by the Municipal Mayor.

SECTION 3. The usual procedures and requirements shall be observed by the Office of the Municipal Civil Registrar, but before the pertinent papers shall be forwarded to the Office of the Mayor, the Official Receipt showing payment of the Solemnization Fee shall have been attached thereto.

SECTION 4. SEPARABILITY CLAUSE. Should any provision of this Ordinance be declared illegal or unconstitutional, and hence invalidated, these provisions hereto which are not affected thereby shall remain effective and enforceable.

SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect ten (10) days after its approval, having been posted in at least two (2) conspicuous public places in the Municipality of Tigbauan, Iloilo.

UNANIMOUSLY APPROVED.
