Municipal Ordinance No. 98-001

AN ORDINANCE AMENDING THE 7TH WHEREAS AND SECTION 3 OF MUNICIPAL REGULATION ORDINANCE NO. 92-002, ENTITLED – “AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ISSUE MOTORIZED TRICYCLE OPERATOR’S PERMIT (MTO), TO REGULATE OPERATION THEREOF WITHIN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, PHILIPPINES AND PRESCRIBING PENALTIES THEREFOR”

WHEREAS, the different Tricycle Owners and Drivers Association had requested for fifty centavos increase in Tricycle fare (as per communication sent to the Sangguniang Bayan dated October 29, 1997) due to the recent increase in the prices of gasoline, oil and spare parts;

WHEREAS, the public hearing conducted on December 21, 1997 at the Benjamin Melliza Hall, Tigbauan Municipal Building was attended by Tricycle Operators/Drivers, Barangay Officials headed by Barangay Captains, commuters and all other concerned persons. The official fare in the corresponding zones of service, which were agreed during the public hearing is shown in Section I;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo that:

SECTION 2. - Separability Clause - If, for any reasons, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 3 - Effectivity Clause - This ordinance shall take effect ten (10) days after having been posted in 2 conspicuous public places in the Municipality and likewise, copies of this ordinance shall be furnished Office of the Sangguniang Panlalawigan of Iloilo for their review and comments.
