Municipal Ordinance No. 99-001

AN ORDINANCE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 26, SERIES OF 1980, ENTITLED, "AN ORDINANCE PROHIBITING THE SALE OF THE BAMBOO SHOOTS IN THE PUBLIC MARKET OR ANY PLACE IN THE MUNICIPALITY"

WHEREAS, a Municipal Ordinance has been passed prohibiting the sale of bamboo shoots in the public market or any other place in the municipality;

WHEREAS, Section 3 of the said Municipal Ordinance provides a fine of Twenty (P20.00) to Fifty Pesos (P50.00) per bamboo shoots for the First offense, One Hundred Pesos (P100.00) per bamboo shoot for the Second Offense and Thirty (30) days imprisonment for the Third Offense;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Tigbauan that:

SECTION 1. Section 3 of Municipal Ordinance No. 16, Series of 1980 shall be amended.

SECTION 2. Violators of this Ordinance shall be punished with a fine of Fifty Pesos (50.00) for the First Offense, One Hundred Pesos (P100.00) for the Second Offense and Thirty (30) days imprisonment for the Third Offense.

SECTION 3. This Ordinance shall take effect after approval and having been posted for 3 consecutive weeks in 3 conspicuous public places in the Municipality of Tigbauan, Province of Iloilo.
