Municipal Ordinance No. 2000 - 002

AN ORDINANCE AMENDING SECTION 1 OF MUNICIPAL ORDINANCE NO. 98 - 002, AN
ORDINANCE DECLARING THE SECOND FRIDAY OF OCTOBER EACH YEAR AS "ADLAW
SANG TIGBAUAN", THIS MUNICIPALITY, PROVINCE OF ILOILO

SECTION 1 - That Section 1 of Municipal Ordinance No. 98 -002, states that the second
Friday of October shall be declared as "ADLAW SANG TIGBAUAN" and it
shall be strictly observed every year by the residents, this Municipality, Province
of Iloilo.

SECTION 2 - That the amendment shall state that the 3rd Friday of October shall be declared as
"ADLAW SANG TIGBAUAN" and it shall be strictly observed every year by
the residents of this Municipality of Tigbauan, Province of Iloilo.

SECTION 3 - This Ordinance shall take effect upon approval.
