**MUNICIPAL ORDINANCE NO. 2000-004**

AN ORDINANCE AMENDING CHAPTER V, ARTICLE D., SECTION 5D.03 a) OF MUNICIPAL ORDINANCE NO. 99-002 – AN ORDINANCE ENACTING THE 1999 MUNICIPAL REVENUE CODE OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS Section 5D.03. TIME AND MANNER OF PAYMENT, a) For Market Stalls states: The fee for the rental of market stalls shall be paid to the Municipal Treasurer or his duly authorized representative within the first twenty (20) days of each month. In case of new lease, the rental due for the month in which the lessee starts, shall be paid before he occupy the stall;

WHEREAS, the Sanggunian in session assembled on November 28, 2000 made some amendments by deleting the word “twenty (20)” after the word “first” and before the word “days” by inserting the words “five” (5) working”;

WHEREAS, the amended Section 5D.03 a) states that: For Market Stalls – The fee for the rental of market stalls shall be paid to the Municipal Treasurer or his duly authorized representative within the first five (5) working days of each month. In case of new lease, the rental due for the month in which the lessee starts shall be paid before he occupy the stall;

NOW, THEREFORE, Be It Ordained by the Sangguniang Bayan that:

Section I – Section 5D.03. a) shall be amended to read as follows: For Market Stalls – The fee for the rental of market stalls shall be paid to the Municipal Treasurer or his duly authorized representative within the first five (5) working days of each month. In case of new lease, the rental due for the month in which the lessee starts shall be paid before he occupies the stall;

Section II – This ordinance shall take effect upon approval.
