Municipal Ordinance No. 2001-004

AN ORDINANCE PROHIBITING STORE OWNERS, BUSINESS ESTABLISHMENT FROM SELLING BEER, ALCOHOLIC BEVERAGES, WINE AND LIQUOR TO MINORS AND HIGH SCHOOL STUDENTS

WHEREAS, the state shall protect the welfare of the youth inasmuch as they are the future leaders of the land;

WHEREAS, parents, guardians, teachers and local government shall initiate measures to lead them to wholesome life and better future;

WHEREAS, it shall be inculcated to minors and High School students that drinking intoxicating liquor may lead to the destruction of their studies and their future;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Tigbauan, Province of Iloilo in session assembled that:

Section 1. It shall be prohibited to all Store Owners and business establishment to sell beer, alcoholic beverages, wine & liquors to minors and High School Students

Section 2. Karaoke Bars are likewise prohibited to serve and sell intoxicating liquors to minors and High School Students

Section 3. Minors & High School Students are prohibited to drink intoxicating liquors in public places.

Section 4. The Definition of Terms as used in this ordinance:

- 1) Beer - refers to drinks produced from fermented yeast and malt.
- 2) Alcoholic Beverages – are those drinks containing fraction of alcohol such as whisky, gin, rum, vodka and the like.
- 3) Wine – the fermented juice of the grapes and several other fruits or vegetables.
- 4) Liquor – any alcoholic drinks, especially one that is distilled.
- 5) Minor – those individual 17 years old and below.
- 6) High School Students - those who are enrolled and studying in any secondary school.
- 7) Business establishment – refers to restaurant, refreshment, cafeteria, grocery store and karaoke bar, which are open to the public.
- 8) Enforcement officer – shall include Police, Teachers, Barangay Captains, Barangay Tanods and Barangay Kagawads.
- 9) Store Owner – any person or persons whose name/s appears on the Mayors Permit and who operates any business establishment or sari-sari store.

Section 5. Responsible for Posting of Sign - the owner or proprietor of the said store and establishment shall be responsible for providing signs logos or symbols, marking or any other informative devices

Section 6. Penalty clause:

- 1) Violators of this ordinance shall be meted the following :

1. Warnings to violators for the first offense. In cases of minors or High School Student they shall be reported to their school principal for disciplinary action.
2. Cancellation of licenses of registered owner and business establishment for the 2nd offense.
3. Second time offenders shall subject the High School Students and minors to community work such as cleaning the streets, town plaza and school campus during Saturdays and duly supervised by their teachers, Barangay Captains, barangay kagawads and General Services office Personnel or representative. The above community works shall be graduated as follows:

2 nd Offense	-	4 hours
3 rd Offense	-	8 hours
4 th Offense & succeeding	-	16 hours

4. For store owners and business establishment. A fine of Five Hundred Pesos (P500.00) and or 3 days imprisonment or both at the discretion of the court 50% of any fine so collected shall be remitted to the apprehending Barangay while 50% will go to the Municipal Treasurer.

The National High School, Barangay Operation Center, Barangay Council shall conduct a continuing program to educate, inform, disseminate to the public the provision of this ordinance.

Section 7. General Provision, Nothing in this ordinance shall be construed to allow store owners and Business establishment to sell intoxicating liquor to minors and High School Students

Section 8. Separability Clause – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 9. Enforcement – It shall be the responsibility of the municipal authority to administer this regulation ordinance and to promulgate the necessary rules and regulations for its implementation (this includes the Police, School Principals, Teachers, Barangay Captains, Barangay Kagawads and Barangay Tanods)

Section 10. Effectivity – This ordinance shall take effect ten (10) days after having been posted in two (2) conspicuous places.

Section 11. Copies of this ordinance be furnished to the Office of the Mayor, Chief of Police, 52 Barangay Captains of the Municipality of Tigbauan and all National High School Principals of Tigbauan for their information and strict compliance.
