**Municipal Ordinance No. 2003-002**

AN ORDINANCE AMENDING SECTION 3 ( PENALTY CLAUSE) OF ORDINANCE NO. 10. S. 1980 — "AN ORDINANCE PROHIBITING ANY PERSON FROM MOVING HIS BOWELS IN CANALS OR EMPTYING RECEPTACLES CONTAINING HUMAN WASTE THEREON OR URINATING IN POSTS. WALLS OR IN ANY PUBLIC PLACES IN THE MUNICIPALITY OF TIGBAUAN. PROVINCE OF ILOILO

WHEREAS, Municipal Ordinance No. 10. S. 1980 has been approved last December 5. 1980;

WHEREAS, Section 3 of the said Municipal Ordinance provides a fine of (P20.00) Pesos or imprisonment of two (2) days or both at the discretion of the court;

WHEREAS, said penalty has not deterred offenders from committing violations of said ordinance and there is a need to increase the same;

WHEREAS, there is a need to increase the penalty from Twenty (P20.00) Pesos to One Hundred (P100.00) Pesos for first offense: Two Hundred (P200.00) Pesos for second offense: and for third offense. Three Hundred (P300.00) Pesos or imprisonment of 2 days;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Tigbauan that :

SECTION 1 - Section 3 of Municipal Ordinance No. 10, Series of 1980, shall be amended.

SECTION 2 - Violators of this ordinance shall be punished with a fine of One Hundred (P100.00) Pesos for first offense; Two Hundred (P200.00) Pesos for second offense; and for third offense. Three Hundred (P:300.00) Pesos or imprisonment of 2 days or both at the discretion of the Honorable Court.

SECTION 3 - This Ordinance shall take effect upon approval.
