Municipal Ordinance No. 2004-006

AN ORDINANCE AMENDING SECTIONS 36 AND 150 OF THE MARKET CODE OF THE MUNICIPALITY OF TIGBAUAN. PROVINCE OF ILOILO AND ADDENDA TO SECTION 16 AND SECTION 57 ©, (D) & (E) THEREOF

BE IT ORDAINED by the Sangguniang Bayan of Tigbauan, Iloilo that:

SECTION 1 - Section 36 of Municipal Ordinance No. 2003-007, shall be amended to read:
Section 36. Preference to the Filipino Applicants. *"Preferably bonafide residents of Tigbauan and citizens of the Republic of the Philippines who are not legally disqualified or incapacitated can lease market stalls, booths or kiosks in the public market of the Municipality of Tigbauan, Province of Iloilo."*

SECTION 2 - Section 150 shall also be amended to read:

Section 150 - Penalty for 1st, 2nd & 3rd offenses:

1st Offense : Fine of P500.00

2nd Offense : Fine of P1,000.00

3rd Offense : Revocation Of Business Permit And One (1) Month Suspension
From Selling In The Market From The Date Of Apprehension.

SECTION 3 - Section 16 shall likewise be amended to include items B,C,D & E as addenda thereto to read:

Section 16 - Prohibition As Dwelling Place:

- a. No person shall be permitted to pass the night in the public market nor shall any part of the public market be used as a dwelling place.
- b. A curfew shall be imposed on within the public market premises from 9:00 p.m. to 3:30 A.M. daily except during Sunday from 9:00p.m. to 3:00 a.m. Anybody caught within the vicinity between that period will be fined P500.00 or render 10 hours of community service.
- c. An alarm system shall be put up in the public market under the control of market-in-charge or any of its representative. The alarm will be on by 8:30 p.m. to give ample time for the vendors to finish their goods.
- d. Only the PNP, deputized Barangay Tanods and market-in-charge or any Of its representative be allowed to roam around during that period.
- e. All establishments within the public market shall have to be closed by 9:00 p.m. The Market-in-charge or any of its representatives will padlock all exits on major entrances. Any establishment fronting the streets using their exits for entrance of person/persons during the 9:00 p.m. — 3:30 a.m. period will be penalized subject to section 151.

SECTION 4 - Section 57 shall be further amended to include items C,D, & E as addenda thereto, to read:

Section 57 - The Municipality of Tigbauan shall impose and collect the following fish inspection

- A. For the inspection of fish having the length Of 6 inches or more, alimango, kasag, lukon, pasayan, squid P0.30 per kilo or P 10.00 per box having an average weight of 30 kilos.
- B. For the inspection of all sapsap not included in Sub-paragraph A above P0.30 per kilo of P5.00 per box having an average weight of 20 kilos: Provided. however, that the Municipal Market Collector or fish inspector, when performing the duties required by virtue hereof shall annotate in the official receipt the facts of the inspection of the kind and weight of the thing inspected.

- C. **The taking or catching, selling, purchasing, transporting and exporting whales, manta rays (pagi), as well as rare, threatened and endangered species embodied in administrative order no. 193, series of 1998 and administrative order no. 208, series of 2001. Notwithstanding the penalty imposed pursuant to section 97 of RA 8550, violators of this section shall be penalized with a fine of two thousand five hundred pesos (P2,500.00), or an imprisonment of not more than six (6) months and confiscation of the item.**

- D. **The selling of marine products obtained thru blast fishing or the use of sodium cyanide is punishable under administrative order no. 206 series of 2001 of fisheries. Violators are penalized with fine **of** five hundred (P500.00) pesos and confiscation **of** fish.**

- E. **The selling **of** fishes or vegetables using formalin as preservative is prohibited and violators will be fined in the amount of five hundred (P500.00) pesos and confiscation of the items.**

SECTION 5 - This Ordinance shall take effect Fifteen (15) days upon approval and posting in three (3) conspicuous places in the Municipality for three consecutive days.
