Municipal Ordinance No. 2004-009

AN ORDINANCE IMPOSING A FEE OF TWO HUNDRED PESOS (P200.00) FOR DOCUMENTATION IN ALLOWING ILLEGITIMATE CHILDREN TO USE THE SURNAME OF THEIR FATHER RETROACTIVE ONLY FROM AUGUST 3, 1988 BIRTHS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, *Republic Act 9255 is a consolidation of House Bill No. 4437 and Senate Bill Resolution 2510 are Acts Allowing Illegitimate Children to use the Surname of their Father and was approved last February 2004 and took effect March 19, 2004, fifteen days after it was published in newspaper of general circulation;*

WHEREAS, Republic Act 9255 was primarily created to provide children with the right to use their father's surname;

WHEREAS, Republic Act 9255 was also created to remove the stigma of illegitimacy and reinstate the spirit of the law provides forth the "best interest of the child principle";

NOW, THEREFORE, on motion of Honorable Alfonsito E. Estoce and duly seconded by

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN A SESSION ASSEMBLED:

SECTION 1. Title. This ordinance shall be known as: *"An Ordinance Imposing A Fee Of Two Hundred Pesos (P200.00) For Documentation In Allowing Illegitimate Children To Use The Surname Of Their Father Retroactive Only From August 3, 1988 Births In The Municipality Of The Tigbauan, Province of Iloilo"*

SECTION 2. An amount of Two Hundred Pesos shall be imposed for documentation for allowing illegitimate children to use the surname of their father.

SECTION 3. The usual procedures and requirements shall be observed by the Office of the Municipal Civil Registrar for proper documentation.

SECTION 4. SEPARABILITY CLAUSE. Should any provision of this Ordinance be declared illegal or unconstitutional, and hence invalidated, these provisions hereto which are not affected thereby shall remain effective and enforceable.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect fifteen (15) days after its approval, having been posted in at least two (2) conspicuous public places in the Municipality of Tigbauan, Iloilo.
