MUNICIPAL ORDINANCE NO. 2005-009

AN ORDINANCE REGULATING AND IMPOSING FEES ON THE ISSUANCE OF BIDDERS TENDERS AND BID DOCUMENTS FOR THE PROJECTS AND THE ACQUISITION OF GOODS AND SERVICES IN THE MUNICIPALITY OF TIGBAUAN. PROVINCE OF ILOILO

SECONDED Unanimously

WHEREAS, Republic Act 9184 was passed by Congress which provides for the modernization, standardization and regulation of the procurement activities of the government and for other purposes:

WHEREAS, the Department of Budget and Management has implemented RA 9184 to systematize the procurement process, avoid confusion and ensure transparency the procurement process, including the forms to be used, shall be standardized insofar as practicable;

WHEREAS, the Local Government Unit of Tigbauan has already implemented Republic Act 9184 and to conform to the standards to be used. it is necessary that fees for the procurement of goods and services and infrastructure and consultancy be imposed;

NOW, THEREFORE, Be It Ordained by the Sangguniang Bayan of the Municipality of Tigbauan. Province of Iloilo that:

Section 1. Title. This Ordinance shall be known as *An Ordinance Regulating And Imposing Fees On The Issuance Of Bidders Tenders And Bid Documents For The Projects And The Acquisition Of Goods And Services In The Municipality Of Tigbauan, Province Of Iloilo*"

Section 2. Hereunder provided are the fees for the issuance of the following by the Bids and Awards Committee (BAC):

A. Bidder's Tender - For goods and services

D. Certification as regards to eligibility to participate in bidding for goods, infrastructure and consultancy services P50.00/project/bidder

E. Annual accreditation fee for every supplier, payable on or before April 30 of every year in the amount of P500.00.

Section 3. IN CASE OF PROTEST ON THE DECISIONS OF THE BAC – Decisions of the BAC may be protested by filing a verified position paper and paying a non-refundable protest fee of P 1,000.00 or 1% of the Approved Budget Contract, whichever is higher.

Section 4. All collections and receipts pertaining to the above fees shall be deposited in a trust fund specifically for the expenses of the Bids and Awards Committee.

Section 5. For purposes of uniformity, the terms being used in this ordinance shall be the same as defined under Republic Act 9184 and its implementing rules and regulations.

Section 6. Repealing Clause - All previous ordinances, rules and regulations or parts thereof which are inconsistent with this ordinance are hereby repealed or modified accordingly.

Section 7. Separability Clause – If for any reason/s any portion or provision of this ordinance is declared unconstitutional or invalid, the other portions or provisions hereof which are not affected thereby. shall continue to be in full force and effect.

Section 8. Effectivity Clause – This ordinance shall take effect ten (10) days after its approval and having been posted in three (3) conspicuous public places in the Municipality of Tigbauan, Province of Iloilo.
