Municipal Ordinance No. 2006-001

AN ORDINANCE ALLOCATING FIFTY (50%) SHARE OF THE PHILIPPINE NATIONAL POLICE (PNP), MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, FROM THE COLLECTION OF POLICE CLEARANCE AND POLICE REPORT

WHEREAS, the Municipality of Tigbauan has a population of fifty four thousand eight hundred fifty four (54,854) as of the last census and we have only twenty one (21) police personnel to maintain peace and order in the whole municipality;

WHEREAS, the PNP-Tigbauan personnel with their commitment to public service of safeguarding lives and properties of the people of Tigbauan sometimes render round-the-clock service for twenty four hours;

WHEREAS, the budget of the PNP-Tigbauan is not enough to maintain and sustain their expenses in maintaining peace and order in the Municipality of Tigbauan;

NOW, THEREFORE, Be It Ordained By The Sangguniang Bayan of Tigbauan, Iloilo, that:

SECTION 1. TITLE - This ordinance shall be known as “*An Ordinance Allocating Fifty (50%) Share Of The Philippine National Police (PNP), Municipality Of Tigbauan, Province Of Iloilo, From The Collection Of Police Clearance and Police Report*”.

SECTION 2. All collections from Police Clearance and Police Report, 50% of which shall be deposited to the Trust Fund of the Municipality of Tigbauan to augment the budget of the PNP for the maintenance of the Police Department and other operational expenses vital to their effective police functions and 50% shall be deposited to the General Fund of the Municipality of Tigbauan.

SECTION 3. The PNP-Tigbauan thru, its Chief of Police, shall submit to the Municipal Treasurer the total monthly expenses in support to their 50% share from the collection of police clearance and police report.

SECTION 4. EFFECTIVITY – This ordinance shall take effect after fifteen (15) days of its approval.
