Municipal Ordinance 2006-004

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 98-003 – "AN ORDINANCE REGULATING THE USE OF THE MUNICIPAL AMBULANCE FOR EMERGENCY CALLS ONLY

WHEREAS, Sec. 447 of the Local Government Code of 1991 (RA 7160) states that the Sanggunang Bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Sec. 16 of RA 7160 and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this code;

WHEREAS, it shall generate and maximize the use of resources and revenues for the development plans, program, objectives and priorities of the municipality as provided for under Section 18 of this Code with particular attention to agro-industrial development and countryside growth and progress;

WHEREAS, relative thereto, it shall prescribe reasonable limits and restraints on the use of property within the jurisdiction of the municipality;

WHEREAS, the cost of fuel, oil, lubricants, spare parts and other ambulance maintenance has increased tremendously and because of budgetary constraints, the Municipal Health Department can no longer maintain the necessary expenses needed for the effective delivery of health services to the community;

WHEREAS, of the reason abovestated and for efficient and effective delivery of health services, the Municipal Health Officer recommended to the Municipal Mayor for the increase of the ambulance fees subject to the approval of the Sanggunian;

WHEREAS, the S.B. Committee Chairman on Health and Sanitation presented to the Honorable Sangguniang Bayan of Tigbauan, Iloilo for consideration the following ambulance fees increase:

a. Tigbauan to Pedro Trono Memorial Hospital, Guimbal, Iloilo
 b. Tigbauan to Iloilo
 c. Pedro Trono Memorial Hospital to Iloilo
 d. Destination outside those specified above
 P100.00
 P300.00
 P400.00
 P20/km

NOW, THEREFORE, Be it ordained by the Honorable Members of the Sangguniang Bayan of Tigbauan, Province of Iloilo, That:

SECTION 1. TITLE – This Ordinance Shall Be Known As "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 98-003 – "AN ORDINANCE REGULATING THE USE OF THE MUNICIPAL AMBULANCE FOR EMERGENCY CALLS ONLY"

SECTION 2. The municipal ambulance must always be parked or at stand-by in the premises of the Municipal Hall, and its driver on 24-hour call.

SECTION 3. Only drivers duly authorized by the Department Head of the Municipal Health Office (MHO) are allowed to operate the vehicle.

SECTION 4. The municipal ambulance must only be used on matters concerning health services:

- a. To serve the needs of the Municipal Health Unit;
- b. To be used during emergency cases per assessment of municipal physicians;
- c. The use of the ambulance for non-emergency cases, such as ferrying patients from the hospital back to his/her home, shall be subject on the units availability and upon the discretion of the department head (MHO);
- d. Private physicians having emergency patients that need to be brought to the hospital must coordinate with the Municipal Health Officer or with Municipal Physicians regarding the use of the ambulance.

SECTION 5. Trip tickets must be duly accomplished before using the ambulance in non-emergency cases and during emergency cases, trip tickets must be duly accomplished within 24 hours after the use of the ambulance. All referrals must be entered in a logbook to be maintained for the purpose.

SECTION 6. The following fees shall be imposed on the use of the municipal ambulance to cover expenses on fuel, oil, lubricants, spare parts and other ambulance maintenance:

a. Tigbauan to Pedro Trono Memorial Hospital, Guimbal, Iloilo
b. Tigbauan to Iloilo
c. Pedro Trono Memorial Hospital to Iloilo
d. Tigbauan to other place

P300.00
P400.00
P20/km

SECTION 7. Indigents duly certified by the Punong Barangay concerned shall be exempted from payment of the imposed fee.

SECTION 8. Payment will be collected by the Municipal Treasurer's Office which in turn shall issue an Official Receipt for every transactions made.

SECTION 9. Repealing Clause – All previous ordinances, rules and regulations or parts thereof which are inconsistent with this ordinance are hereby repealed or modified accordingly.

SECTION 10. Separability Clause – If for any reason/s any portion or provision of this ordinance is declared unconstitutional or invalid, the other portions or provisions hereof which are not affected thereby, shall continue to be in full force and effect.

SECTION 11. Effectivity Clause – This Ordinance shall take effect ten (10) days after its approval and having been posted in three (3) conspicuous public places in the Municipality of Tigbauan, Province of Iloilo.
