**Municipal Ordinance No. 2006-006**

AN ORDINANCE REGULATING AND IMPOSING FEE FOR THE USE OF ECG MACHINE OF THE MUNICIPAL RURAL HEALTH UNIT OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Sec. 447 of the Local Government Code of 1991 (*RA 7160*) states that the Sangguniang Bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Sec. 16 of *RA 7160* and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this code;

WHEREAS, it shall generate and maximize the use of resources and revenues for development plans, program, objectives and priorities of the municipality as provided for under Section 18 of this code with particular attention to agro-industrial development and countryside growth and progress;

WHEREAS, subject to the provisions of Rule XXIII of Local Health Boards and in accordance with the standards and criteria of the Department of Health (DOH), provision on health services which include the implementation of programs and projects on primary health care, maternal and child care and communicable and non-communicable disease control services; and access to secondary and tertiary health services shall be implemented;

WHEREAS, relative thereto, it shall prescribe reasonable limits and restraints on the use of property within the jurisdiction of the municipality;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO THAT:

SECTION 1. TITLE – This ordinance shall be known as “AN ORDINANCE REGULATING AND IMPOSING FEE FOR THE USE OF ECG MACHINE OF THE MUNICIPAL RURAL HEALTH UNIT OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO”.

SECTION 2. The Electrocardiograph (ECG) Machine is an instrument for recording the changes of electrical potential occurring during the heartbeat, used especially in diagnosing abnormalities of heart action and the tracing made by this instrument is known as electrocardiogram or EKG.

SECTION 3. The ECG machine must always be in the premises of the Rural Health Unit of the Municipality of Tigbauan.

SECTION 4. Only authorized personnel shall be allowed to operate the said machine.

SECTION 5. The ECG machine must only be used on matters concerning health services of the general populace and other special cases on the discretion of the department head of the Rural Health Unit of the Municipality of Tigbauan.

SECTION 6. Request forms approved by the department head of the Rural Health Unit must be presented for payment before availing the said service and all transactions be entered in the log book to be maintained for the purpose of monitoring and proper auditing;

SECTION 7. A fee of Php 200 shall be imposed for the use of ECG Machine. Fifty percent (50%) of the amount collected shall go to the Trust Fund for the maintenance of the said machine and the remaining fifty percent (50%) shall go to the general fund of the Municipality of Tigbauan.

SECTION 8. Payment shall be collected by the Municipal Treasurer's Office which in turn shall issue an Official Receipt for every transactions made.

SECTION 9. Indigents duly certified by the Punong Barangay concerned shall be exempted from payment of the imposed fee.

SECTION 10. The 50% share of the Rural Health Unit for all transactions made using the said machine shall be turned over to the Department Head of the Rural Health Unit of the Municipality of Tigbauan for the sole purpose of the ECG machine maintenance.

SECTION 11. Repealing Clause – All previous ordinances, rules and regulations or parts thereof, which are inconsistent with this ordinance, are hereby repealed or modified accordingly.

SECTION 12. Separability Clause – If for any reason/s any portion or provision of this ordinance is declared unconstitutional or invalid, the other portions or provisions hereof which are not affected thereby, shall continue to be in full force and effect.

SECTION 13. Effectivity Clause – This Ordinance shall take effect ten (10) days after its approval and having been posted in three (3) conspicuous public places in the Municipality of Tigbauan, Province of Iloilo.
