Municipal Ordinance No. 2008-004

AN ORDINANCE CREATING THE LOCAL SPORTS DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND FOR OTHER PURPOSES

Be it ordained by the Municipality of Tigbauan, that:

Section 1. Title – This ordinance, shall be known as the “Local Sports Development Council” of the Municipality of Tigbauan, Province of Iloilo.

Section 2. Declaration of Policy – It is a declared policy of the municipality to promote and strengthen the sports for all programs and encourage total involvement and participation of every individual/ sector of the community in sports programs and activities. Recognize and assist potential Tigbauanon athletes in their field of specialization.

Section 3. Definition of Terms – as used in this ordinance, the following terms shall mean:

- (1) Sports – refers to all recognized sports activities that a Tigbauanon athlete could participate in, may it be an individual, dual or team sports or may it be an exhibition or a competition game.

- (2) Pool of athletes – refers to a group of Tigbauanon athletes who are recognized by the Local Sports Development Council and in top priority to represent the municipality in any sports activities the council may join.
- (3) Pool of officials- refers to all recognized officials by the Local Sports Development Council and in top priority to officiate in any municipal league organized by the Council.
- (4) Sports association/organization – refers to all clubs or organizations that are recognized by the municipality as a sports association/organization
- (5) Municipality – refers to the Municipality of Tigbauan
- (6) Barangay – refers to the 52 barangays of Tigbauan
- (7) Athlete – refers to a Tigbauanon player participating in any sports activity
- (8) Tigbauanon Athlete – refers to a player who resides in Tigbauan or one who is related by affinity or consanguinity to Tigbauanon.

Section 4. Local Sports Development Council – there shall be created a Local Sports Development Council which shall be responsible for the formulation of policies and implementation of sports development programs, projects and activities in coordination with various government and non-government organizations.

Section 5. Purpose - The primary goal of this ordinance is to enhance total sports for all programs with the active participation of every individual and sector of this municipality

Section 6. Objectives – Local Sports Development Council shall have the following objectives:

- 1. To be the leading council that will provide sports program to all Tigbauanons.
- 2. To encourage active participations of all sectors towards the development of the sports program.
- 3. To provide a just and transparent system of athlete selection that will represent the municipality.
- 4. To provide well competent and impartial officials that will organize and manage the sports activities.
- 5. To harmonize all barangay sports program for the development of our municipal sports programs.
- 6. To provide information mechanism on sports related concerns to all Tigbauanons.
- 7. To provide venue for the proper recognition and identification of Tigbauanon athletes who give honor to the municipality.
- 8. To assist potential athletes to excel in their field of specialization.

Section 7a. Composition of the Council – The council shall be composed of the following:

- Chairman – Municipal Mayor
- Co-chairmen – SKMF President
- SB member Committee on Youth and Sports Members
- a. Municipal Program Development Officer
- b. District Supervisor/For Elementary Level
- c. Principal, Secondary Schools
- d. Chairman, Committee on Social Services, Senior Citizens, Disabled Persons, Cultural Minorities, Indigents and NGO's
- e. One (1) representative for every recognized sports associations in the whole municipality
- f. Liga President
- g. SK Chairmen
- h. Municipal Health Representative
- i. Physical Education Teacher (One (1) from elementary, One (1) from High School/both public and private)

Section 7b. Membership requirements for NGO's and other sports-related associations.

- a. Recognized by the S.B. Committee on Social Services, Senior Citizens, Disabled Persons, Cultural Minorities, Indigents and NGO's.
- b. Submit to the Local Sports Development Council the following requirements:
 1. Letter of intent to become a member of the council
 2. Constitution and By-Laws of the organization
 3. List of the officers and members
 4. Proposed program of activities
- c. Acquire approval of membership/recognition from the Office of the Mayor.

Section 8. Functions of the Local Sports Development Council – The following shall be the functions of the Local Sports Development Council:

- a.) To formulate policies and component programs in coordination with the various government agencies handling sports-related programs, projects and activities.
- b.) To coordinate and harmonize activities of all barangays, schools and organizations in the municipality engaged in sports development programs.
- c.) To provide and support for the development and coordination of sports projects and design strategies to gain support and participation of all sectors in the municipality.
- d.) To assist the local and national government agencies in the identification and nomination of qualified participants to different programs, projects and activities in the local level.
- e.) To conduct fund raising programs and solicitations. It shall likewise receive donations, bequests and may enter into contracts with other government and non-government agencies necessary for the accomplishment of the objectives of this ordinance;
- f.) To recommend sports programs and project proposals to appropriate government agencies and non-government organizations;
- g.) To accredit Training pools for athletes and officials to appropriate agencies both public and private necessary for the accomplishment of the objectives of this ordinance;
- h.) To nominate qualified members to any local and national sports activities;
- i.) To establish sports centers as necessary;
- j.) To monitor implementation of programs and projects of the council at the local level;
- k.) Perform such other functions as may be provided by law

Section 9. Local Sports Development Plan – The Council shall formulate and adopt a five year municipal sports development plan which shall be duly supported by an ordinance enacted by the Sangguniang Bayan. The said plan shall be the basis for the implementation of the Local Sports Development programs and services in coordination with concerned agencies. These shall include school base and barangay-base sports programs and services.

Section 10. Budget – The Local Chief Executive shall allocate necessary fund every year for the utilization of the Local Sports Development Council and this shall be part of the Municipal Budget.

Section 11. Sports Center – The Council may establish a Sports Center which shall be located in the Municipal Proper. The Sports Center shall operate as a multi-purpose center to accommodate sports –related concerns.

Section 12. Meetings of the Council – The Council shall meet at least once a month or as often as maybe deemed necessary. The Chairman or his duly designated convener shall preside in all council meetings.

Section 13. Privileges – To promote active participation, the following privileges shall be given:

- 1. Members of the Pool of Athletes shall be in top priority to represent the municipality in any in and out of town games, and shall avail benefits as provided by the municipality.
- 2. Members of the Pool of Officials shall be in top priority to officiate in the municipal leagues and represent the municipality in the seminar-workshops both local and national.

Section 14. Repealing Clause – Any ordinance with provisions that contradict this Ordinance is hereby repealed.

Section 15. Effectivity – This ordinance shall take effect after mandatory posting of 10 days in conspicuous places within this Municipality, and intensive information dissemination within the same period.
