Municipal Ordinance No 2010- 001

AN ORDINANCE REGULATING AND DECLARING THE FRONT OF THE MUNICIPAL BUILDING AS NO PARKING ZONE FOR PRIVATELY OWNED VEHICLES AFTER WORKING HOURS, WEEKENDS, HOLIDAYS AND PROVIDING PENALTIES IN VIOLATION THEREOF

WHEREAS, the front of the municipal building serves as parking area for the municipality's vehicles and sometimes used as alternative venue for some of the municipality's activities;

WHEREAS, private individuals with vehicles while conducting business in the municipal building also park their vehicles in the area intended for the municipality's vehicles thus displacing our vehicles;

WHEREAS, some private individuals leave their vehicles parked for several hours unattended long after doing business in the municipal hall during office hours. While others even uses the area as their private parking area after office hours, weekends and holidays that security guard finds it difficult to locate their owners when the area is needed for the activity;

NOW, THEREFORE, upon motion of Hon. Norberto Turalba and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton O. Tumabotabo, Hon. Jose Tavarro, Jr., Hon. Loreta Lungay-Arias, Hon. Elmer Torrato, and Hon Orvillo Tangente;

BE IT ORDAINED, as it is hereby ordained, by the Sangguniang Bayan in session assembled that:

SECTION 1. TITLE OF THE ORDINANCE - *"An Ordinance Regulating And Declaring The Front Of The Municipal Building As No Parking Zone For Privately Owned Vehicles After Working Hours, Weekends, Holidays And Providing Penalties In*

Violation Thereof'.

SECTION 2. PARKING TIME FOR PRIVATE VEHICLES

1. Private individuals with vehicles shall be allowed to park in front of the municipal hall from 8 AM - 5 PM Monday - Friday only while doing their business transactions. Upon entering the municipal building, the owner shall inform the security guard on duty so that the time, brand, color, plate number and purpose of the visit will be recorded in the log book.
2. Official visitors of the municipality shall be allowed to park any time of the day in a week as long as the Office of the Mayor grants the consent.
3. The Office of the Municipal Mayor shall issue municipal stickers for the vehicles of municipal employees for identification purposes.

Only those vehicles with municipal stickers will be allowed to park during office hours.

4. No vehicle shall be allowed to park in front of the Municipal Building during the Municipal sanctioned activities held within the vicinity.

SECTION 3. PENALTY IN VIOLATION THEREOF:

1. P50.00/hour is charged upon the owner/driver for intentionally parking his/her vehicle more than 2 hours long after transacting business in the municipal hall.
2. P500.00/day shall be imposed upon the owner/driver who parks his/her vehicle after office hours, weekends and holidays.

SECTION 4. REPEALING CLAUSE. All Ordinances, Executive Orders, Resolutions, and/or Administrative Regulations, or part thereof which are inconsistent with this Ordinance are hereby repealed and/or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE. Should any provision of this ordinance be subsequently declared invalid, the other provisions not so declared shall remain in full force and effect.

SECTION 6. EFFECTIVITY CLAUSE. This Ordinance shall take effect fifteen (15) days after approval and posted in three (3) conspicuous places in the municipality.
