Municipal Ordinance No. 2011-003

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE OF THIS MUNICIPALITY TO AUGMENT THE AMOUNT OF TWO MILLION TWO HUNDRED EIGHTY TWO THOUSAND FIVE HUNDRED SIXTY SEVEN PESOS (P2,282,567.00) FOR THE GRANTING OF PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) TO GOVERNMENT PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN FOR THE FISCAL YEAR 2011 PER BUDGET CIRCULAR NO. 2011-04 DATED DECEMBER 5, 2011 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT.

WHEREAS, 1st indorsement dated December 9, 2011 of Hon. James Excelsior M. Torres, Municipal Mayor, respectfully indorsing to the Office of the Sangguniang Bayan, Tigbauan, Iloilo thru the Presiding Officer the request for the urgent passing of a Resolution for the Augmentation of Funds for Payment of Productivity Enhancement Incentive (PEI) of the Municipal Officials and Employees of the Local Government Unit of Tigbauan for CY 2011 per Budget Circular No. 2011-04 dated December 5, 2011 of the Department of Budget and Management;

WHEREAS, a **Certification** issued by the Local Finance Committee, states that the amount of Two Million Two Hundred Eighty Two Thousand Five Hundred Sixty Seven Pesos (P2,282,567.00) is available for the granting of the Productivity Enhancement Incentive (PEI),

to be taken from the CY 2011 Personal Services Savings, a copy of which is hereto attached as **Annex "A"**, forming part of this Ordinance;

WHEREAS, Sec. 336 of the Local Government Code provides that: *Use of Appropriated Funds and Savings.* - Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations” ;

NOW, THEREFORE, Be It Ordained by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, that:

Section 1. The Local Chief Executive is hereby authorized to augment the amount of Two Million Two Hundred Eighty Two Thousand Five Hundred Sixty Seven Pesos (P2,282,567.00) for the payment of the grant of the Productivity Enhancement Incentive to Government Personnel of the Local Government Unit of Tigbauan for Fiscal Year 2011.

Section 2. Such augmentation shall be charged against the savings from Personal Services for the CY 2011;

Section 3. The appropriated amount as embodied in this Appropriation Ordinance shall be used solely for the purpose of payment of Productivity Enhancement Incentive to Government Personnel of the Local Government Unit of Tigbauan for Fiscal Year 2011, subject to the provisions in Budget Circular No. 2011-4 dated December 5, 2011 issued by the Department of Budget and Management. Disbursements of funds relative thereto shall be subject to usual accounting and auditing rules and procedures and other applicable laws.

Section 4. This Ordinance for Augmentation of Fund shall take effect upon approval.

ENACTED. December 16, 2011.
