**Municipal Ordinance No. 2013-001**

AN ORDINANCE REQUIRING ALL MOTORCYCLE RIDERS PLYING ALONG BARANGAY, MUNICIPAL, PROVINCIAL AND NATIONAL ROADS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF TIGBAUAN TO WEAR STANDARD PROTECTIVE MOTORCYCLE HELMET WHILE RIDING

WHEREAS, wearing standard protective motor helmet is mandated and prescribed by Republic Act 10054 or the Motorcycle Helmet Act (*enacted last June 2010*);

WHEREAS, it is a fact that wearing such protective helmet is a safety measure for motorcycle riders;

WHEREAS, it has been observed that most motorcycle riders are not wearing protective helmet while plying within the territorial jurisdiction of the municipality;

WHEREAS, there has been a number of motorcycle related accidents which caused death and injuries that may have been prevented or injuries mitigated had the rider worn a protective helmet.

NOW THEREFORE, ***Be It Ordained By The Honorable Sangguniang Bayan of Tigbauan, Iloilo, that:***

**Section 1. Title:** This Ordinance shall be known as "AN ORDINANCE REQUIRING ALL MOTORCYCLE RIDERS PLYING ALONG THE BARANGAY, MUNICIPAL, PROVINCIAL AND NATIONAL ROADS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF TIGBAUAN TO WEAR STANDARD PROTECTIVE MOTORCYCLE HELMET WHILE RIDING."

**Section 2. Definition of Terms:**

1. **Single Motorcycle** - a mode of transportation with two wheeled motor vehicle
2. **Rider** - one who rides or drives as the operator of a motorcycle
3. **Standard Motorcycle Helmet** – any of various protective motorcycle helmet, ICC approved, usually made of hard materials to resist impact.
4. **Traffic Citation Ticket** - A ticket issued to a person who violates the provisions of this ordinance which shows other information such as the name, address of the offender and a statement or information that constitute a complaint charging the violator of the offense committed.
5. **Apprehending Officer**- refers to any legitimate, recognized and duly designated traffic enforcer of the LGU as well as the local PNP Officers who shall apprehend violators of the provisions of this ordinance.

**Section 3. PROVISION:** All riders of motorcycle plying along the barangay, municipal and national roads within the territorial jurisdiction of Tigbauan are hereby required to wear standard protective motorcycle helmet while riding a motorcycle.

**Section 4. PROHIBITED ACTS:**

- a. Non-wearing of standard protective motorcycle helmet while riding a motorcycle.
- b. Wearing of standard protective motorcycle helmet/wearing of a protective motorcycle helmet with unlocked strap.

**Section 5. PENALTIES:**

All riders found to have violated any provision of this ordinance shall be penalized with a fine of :

1. 1<sup>st</sup> offense – P300.00
2. 2<sup>nd</sup> offense – P500.00
3. 3<sup>rd</sup> offense – P1,000.00

**Section 6. REWARDS AND INCENTIVE SCHEME.** To effectively implement this ordinance, a reward and incentive scheme is hereby institutionalized. Under the said scheme, 50% of the penalty for violation of this ordinance from every violator shall go to the apprehending officer and the other 50% shall accrue to the municipal government.

**Section 7. REPEALING CLAUSE.** Any prior ordinance in conflict or inconsistent with this ordinance shall be deemed repealed or amended accordingly.

**Section 8. SEPARABILITY CLAUSE.** In the event any part or portion of this ordinance is declared to be illegal, unconstitutional or invalid, those parts or portions thereof which are not affected thereby shall continue to be effective and enforceable.

**Section 9. EFFECTIVITY CLAUSE.** This ordinance shall take effect after compliance with the required mandatory posting under Section 511 of R.A. 7160, the Local Government Code of 1991.
