Municipal Ordinance No. 2014-004

AN ORDINANCE FOR THE TEMPORARY CLOSURE OF A PORTION OF TAÑEZA STREET AND TALAVER STREET, THIS MUNICIPALITY IN VIEW OF ROAD CONCRETING AND REPAIR.

WHEREAS, to facilitate the concreting of portion of Tañeza Street and repair of its drainage system, it is necessary that portion of Tañeza Street and Talaver Street, this municipality, be closed to motor vehicles until said concreting and repair works are completed;

WHEREAS, Section 21 paragraphs (a) and (c) of RA 7160 of the Local Government Code of 1991 states: "Closure and Opening of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction...;

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall be temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned;

BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

Section 1. COVERAGE – In connection with the above mentioned concreting and repair works, portion of Tañeza Street and Talaver Street, this municipality, shall be temporarily closed to motor vehicles;

Section 2. DURATION AND TIME. The closure of portion of Tañeza Street and Talaver Street shall take effect upon commencement of the concreting and repair works until completed, but not later than March 30, 2014.

Section 3. MISCELLANEOUS PROVISIONS.

The Punong Barangay of Barangay 1 Poblacion, this municipality, through the Barangay Tanods, shall facilitate the implementation of this ordinance and maintain orderly road utilization of Tañeza Street and Talaver Street on the duration of their temporary closure.

Section 4. SEPARABILITY CLAUSE – If any provision of this ordinance be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5. **EFFECTIVITY** – This Ordinance shall take effect immediately.
