Municipal Ordinance No. 2014-005

AN ORDINANCE AMENDING SECTION 8 OF MUNICIPAL ORDINANCE NO. 2008-011 – IMPOSING FEE FOR THE SERVICE MAINTENANCE OF THE MUNICIPAL BIRTHING CLINIC OF THE RURAL HEALTH UNIT, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND PROVIDING PENALTIES IN VIOLATION THEREOF

WHEREAS, Municipal Ordinance No. 2008-011 has been approved by the Sangguniang Bayan, this Municipality last November 12, 2008 was forwarded for review to the Sangguniang Panlalawigan on November 14, 2008;

WHEREAS, Section 8 of Municipal Ordinance No. 2008-011 “To sustain the operation of the Municipal birthing Clinic, a **service fee of P1,500.00** shall be imposed to augment its basic maintenance needs to be apportioned/distributed as follows: **P500.00** shall go to the **General Fund**; **P500.00** to the **Trust Fund**; and the remaining **P500.00** will serve as **honorarium of the health personnel rendering services after the regular office hours**. For deliveries occurring during office hours (8:00 a.m. to 5:00 p.m.) the charge will only be **P1,000.00** to be distributed as follows: **P500.00** will go to the **General Fund** while the remaining **P500.00** will go to the **Trust Fund**” needs to be amended for the improvement of Health Center Services and Facilities;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF TIGBAUAN THAT:

Section 1. Title: This ordinance shall be known as “An Ordinance Amending Section 8 Of Municipal Ordinance No. 2008-011 – Imposing Fee For The Service Maintenance Of The Municipal Birthing Clinic Of The Rural Health Unit, Municipality Of Tigbauan, Province Of Iloilo And Providing Penalties In Violation Thereof”

Section 2. Section 8 of Municipal Ordinance No. 2008-011 shall be amended, to wit:

“Section 8. To sustain the operation of the Municipal Birthing Clinic, a service fee of P3,500.00 shall be imposed to augment its basic maintenance needs, will go to the Special Account. Otherwise, if there are deliveries being referred by a hilot, a referral fee of P500.00 will be deducted to the service fee.”

Section 3. REPEALING CLAUSE. All ordinances, executive orders, resolutions and or administrative regulations, or parts thereof, which may be inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 4. SEPARABILITY CLAUSE. Any provision of this ordinance which shall be declared invalid shall not affect the other provisions not so declared, which shall remain in full force and effect.

Section 5. EFFECTIVITY. This ordinance shall take effect fifteen (15) days after its approval and posting in three (3) conspicuous places in the municipality.
