AN ORDINANCE TEMPORARILY CLOSING PORTIONS OF ALLERA ST., TIGBAUAN, ILOILO UNTIL DECEMBER 31, 2014 TO SERVE AS RELOCATION SITE FOR THE TEMPORARY STALLS OF VENDORS AFFECTED BY THE IMPLEMENTATION OF THE REHABILITATION OF THE FISH AND MEAT SECTION OF THE TIGBAUAN PUBLIC MARKET.

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

"Closure of Roads - (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx

WHEREAS, the Local Government Unit of Tigbauan will undertake the rehabilitation of the fish and meat section of the Tigbauan Public Market as part of the priority programs of the present administration;

WHEREAS, the said development effort will necessarily displace temporarily some of the fish and meat vendors, thus, the need to provide for a temporary place for them to continue with their means of livelihood so as not to place their family's welfare at stake;

WHEREAS, the LGU has identified portions of Allera Street, Barangay 8 Poblacion, this municipality to serve as relocation for the displaced fish and meat vendors and this would necessitate the closure of the portions of said street until December 31, 2014 to pave the way for the orderly, fast and efficient rehabilitation of the fish and meat section of the Tigbauan Public Market;

BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

Section 1. COVERAGE – In connection with the above-mentioned purpose, portions of Allera Street, Barangay 8 Poblacion, this municipality, shall be temporarily closed to motor vehicles;

Section 2. DURATION AND TIME – The temporary closure shall take effect upon passage of this ordinance until December 31, 2014;

Section 3. MISCELLANEOUS PROVISIONS – The Punong Barangay of Poblacion 8, Tigbauan, Iloilo with the aid of the Barangay Tanods and Tigbauan PNP shall facilitate the implementation of this ordinance and shall maintain the peace and order of the area for the entire duration of this temporary closure.

Section 4. SEPARABILITY CLAUSE – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5. EFFECTIVITY – This Ordinance shall take effect immediately.
