Municipal Ordinance No. 2016-004

AN ORDINANCE FOR THE TEMPORARY CLOSURE OF PORTIONS OF THE ROADS PASSING TEJERO AND ALLERA STREETS OF THIS MUNICIPALITY IN CONNECTION WITH THE CELEBRATION OF THE 2ND PAGDAUG-SALUDAN FESTIVAL ON MARCH 1-19, 2016

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

“Closure of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx

WHEREAS, Pagdaug-Saludan Festival is the official municipal festival of Tigbauan and the said festivity includes having a foodfest, “peryahan” and the highlight which is the Tribal Dance Drama competition;

WHEREAS, the LGU has identified the following portions of roads/streets within the poblacion as sites for the holding of “peryahan”, food festival and Tribal Dance Drama Competition in this municipality:

- A portion of Tejero St., specifically at the back of the Tigbauan Municipal Building passing the Tigbauan Public Market going to Brgy. 9 (Pob.)/Sta. Lucia;
- A portion of Allera Street specifically in front of the Tigbauan Public Plaza passing the side of the Tigbauan Public Market going to Brgy. 8 (Pob.);
- A portion of RC Drive specifically at the back of the Roman Catholic Church.

NOW, THEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

*Section 1. **COVERAGE*** – In connection with the above-mentioned purpose, portions of the roads passing the Tejero & Allera Streets, and RC Drive, Poblacion, this municipality, shall be temporarily closed to motor vehicles.

*Section 2. **DURATION*** – The temporary closure shall take effect upon approval of this ordinance on the following dates:

- Re: specified portions of Tejero St., at the back of the Municipal Bldg. and Allera St. in front of the Public Market - from March 1 to March 19, 2016;
- Re: specified portions of Allera St., in front of the Tigbauan Public Plaza, Tejero St. in front of the Public Market and RC Drive at the back of the Roman Catholic Church - on March 18, 2016.


*Section 3. **MISCELLANEOUS PROVISIONS*** – The Punong Barangays of Poblacion 8 & Poblacion 9, Tigbauan, Iloilo with the aid of their Barangay Tanods and the Tigbauan PNP shall facilitate the implementation of this ordinance and shall maintain the peace and order of the area for the entire duration of this temporary closure.

*Section 4. **SEPARABILITY CLAUSE*** – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

*Section 5. **EFFECTIVITY*** – This Ordinance shall take effect immediately.
