**Municipal Ordinance No. 2016 – 013**

AN ORDINANCE TEMPORARILY CLOSING PORTION OF TRONCO STREET, BARANGAY 5, POBLACION, TIGBAUAN, ILOILO DUE TO THE DEATH AND WAKE OF CLARA T. TABANG

*Sponsored By:* HON. RONNIE PAGUNTALAN, *Chairperson, Committee on Barangay Affairs,*  
*Seconded By:* Hon. Renee Librodo-Valencia, Hon. Ma.Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno and Hon. Ariel Bernardo

WHEREAS, to accommodate relatives and friends who will come to visit and attend the wake of Clara T. Tabang, portion of Tronco Street, Barangay 5, Poblacion, Tigbauan will be utilized, that temporary structures may hamper the flow of traffic in the area;

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

*“Closure of Roads – (a) A local government unit may. Pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx; (c)Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx”*

WHEREAS, upon request of the Punong Barangay of Barangay 5 Poblacion, Tigbauan and for humanitarian reasons, the members of the Sanggunian voted to pass an ordinance temporarily closing the above-mentioned road;

BE IT ORDAINED, therefore, by the Honorable Sangguniang Bayan, that:

*Section 1. COVERAGE* – In connection with the above-mentioned purpose, portion of Tronco Street, Barangay 5, Poblacion, this municipality, shall be temporarily closed to motor vehicles;

*Section 2. DURATION AND TIME* – The temporary closure shall be for eight (8) days, from June 23 to June 30, 2016;

*Section 3. MISCELLANEOUS PROVISIONS* – The Barangay Officials of Barangay 5, Poblacion, Tigbauan, Iloilo headed by Punong Barangay John Gershwin C. Tueres, with the Barangay Tanods, shall facilitate the implementation of this ordinance and maintain the peace and order of the area for the duration of the temporary closure of Tronco St..

*Section 4. SEPARABILITY CLAUSE.* – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

*Section 5. EFFECTIVITY.* – This Ordinance shall take effect immediately.
