**Municipal Ordinance No. 2016 – 014**

AN ORDINANCE TEMPORARILY CLOSING PORTION OF TOLOSA STREET (M/V PAPAG), BARANGAY 6, POBLACION, TIGBAUAN, ILOILO DUE TO THE DEATH AND WAKE OF PEDRO T. TUVIDA

*Seconded By:* Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Jerry T. Tuares;

WHEREAS, to accommodate relatives and friends who will come to visit and attend the wake of Pedro T. Tuvida, portion of Tolosa Street (M/V PAPAG), Barangay 6, Poblacion, Tigbauan will be utilized, that temporary structures may hamper the flow of traffic in the area;

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

*“Closure of Roads – (a) A local government unit may. Pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx; (c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx”*

WHEREAS, upon request of Punong Barangay Ma. Lina Tasio-Tavarro of Barangay 6 Poblacion, Tigbauan and for humanitarian reasons, the members of the Sanggunian voted to pass an ordinance temporarily closing the above-mentioned road;

BE IT ORDAINED, therefore, by the Honorable Sangguniang Bayan, that:

**Section 1. COVERAGE** – In connection with the above-mentioned purpose, portion of Tolosa Street (M/V PAPAG), Barangay 6, Poblacion, this municipality, shall be temporarily closed to motor vehicles;

*Section 2. DURATION AND TIME* – The temporary closure shall be for twelve (12) days from July 12, 2016 to July 23, 2016;


*Section 3. MISCELLANEOUS PROVISIONS* – The Barangay Officials of Barangay 6, Poblacion, Tigbauan, Iloilo headed by Punong Barangay , with the Barangay Tanods, shall facilitate the implementation of this ordinance and maintain the peace and order of the area for the duration of the temporary closure of Tolosa Street (M/V PAPAG).

*Section 4.SEPARABILITY CLAUSE.* – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

*Section 5. EFFECTIVITY.* – This Ordinance shall take effect immediately.
