Municipal Ordinance No. 2016-016

AN ORDINANCE TEMPORARILY CLOSING ALLERA STREET (FRONTING ST. JOHN OF SAHAGUN PARISH CHURCH), THIS MUNICIPALITY IN CONNECTION WITH THE CELEBRATION OF THE FEAST DAY OF THE BIRTH OF THE BLESSED VIRGIN MARY ON SEPTEMBER 8, 2016.

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

"Closure of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;
(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx

WHEREAS, Msgr. Rolando Haguisan, Parish Priest of the Catholic Parish of Tigbauan, will be hosting in this municipality the Feast Day of the Birth of the Blessed Virgin Mary on September 8, 2016;

WHEREAS, on this occasion, the Municipality of Tigbauan will be expecting a large number of parishioners coming from different barangays of this municipality and also visitors coming from other towns;

WHEREAS, the LGU has identified portion of Allera Street (*Fronting St. John Of Sahagun Parish Church*), this municipality to be closed to traffic on September 8, 2016 in such a way that Public Utility Vehicles (PUJs) shall not be allowed to park therein and stalls used by vendors and peddlers shall be transferred from the area;

WHEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

Section 1. COVERAGE – In connection with the above-mentioned celebration, portion of Allera Street (*Fronting St. John Of Sahagun Parish Church*), this municipality, shall be temporarily closed to motor vehicles and vendors;

Section 2. DURATION AND TIME – The temporary closure shall take effect on September 8, 2016;


Section 3. MISCELLANEOUS PROVISIONS – The Punong Barangays of Poblacion 1, 8 and 9, Tigbauan, Iloilo with the aid of their Barangay Tanods and Tigbauan PNP shall facilitate the implementation of this ordinance and shall maintain the peace and order of the area for the entire duration of the temporary closure.

Section 4. SEPARABILITY CLAUSE – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5. EFFECTIVITY – This Ordinance shall take effect immediately.
