Municipal Ordinance No. 2016 – 018

AN ORDINANCE TEMPORARILY CLOSING PORTION OF TANTIADO STREET, BARANGAY 5, POBLACION, TIGBAUAN, ILOILO DUE TO THE DEATH AND WAKE OF DOLORES LEDESMA

Sponsored By: HON. JERRY TUARES, Vice-Chairman, Committee on Barangay Affairs Seconded By: Hon. Dennis T. Valencia Hon. John Gershwin Tueres, Hon. Ariel Bernardo, Hon. Suzette Marie Hilado-Banno and Hon. Neri T. Camiña;

WHEREAS, in order to accommodate family members, friends, and relatives who will come to pay homage to the late Dolores Ledesma certain structure will be set-up outside their residence at portion of Tantiado Street, Barangay 5, Poblacion, Tigbauan, Iloilo which may hamper the free flow of traffic in the area;

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

"Closure of Roads – (a) A local government unit may. Pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx; (c)Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx"

WHEREAS, upon request of Punong Barangay Joyce P. Tapales of Barangay 5 Poblacion, Tigbauan and for humanitarian reasons, the members of the Sanggunian voted to pass an ordinance temporarily closing the above-mentioned road;

BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

Page 2-Mun.Ord.No.2016-018

Section 1. COVERAGE – In connection with the above-mentioned purpose, portion of Tantiado Street, Barangay 5, Poblacion, this municipality, shall be temporarily closed to motor vehicles;

Section 2. DURATION AND TIME – The temporary closure shall be for eighteen (18) days from October 12, 2016 to October 29, 2016;

Section 3. MISCELLANEOUS PROVISIONS – The Punong Barangay of Barangay 5, Poblacion, Tigbauan, Iloilo with the aid of the Barangay Tanods shall facilitate the implementation of this ordinance and shall maintain the peace and order of the area for the entire duration of this temporary closure.

Section 4. SEPARABILITY CLAUSE. – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5. EFFECTIVITY. – This Ordinance shall take effect immediately.
