### **Municipal Ordinance No. 2016 – 019**

AN ORDINANCE TEMPORARILY CLOSING THE HALF PORTION OF THE NATIONAL HIGHWAY ALONG BARANGAY 7 (*POBLACION*) IN FRONT OF THE TIGBAUAN CATHOLIC CEMETERY (*PARTICULARLY THE LEFT LANE THEREOF GOING TO ANTIQUE*) IN CONNECTION WITH THE “ALL SAINTS DAY” AND “ALL SOULS DAY” CELEBRATIONS.

WHEREAS, as experienced during the previous years, the volume of people visiting their dead causes traffic congestion in front of the Tigbauan Catholic Cemetery resulting to gross delay and inconvenience to motorists;

WHEREAS, Section 21 paragraphs (a) and (c) of RA 7160 of the Local Government Code of 1991 states: “**Closure and Opening of Roads** – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction...;

(c) Any national or local road, alley, park or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, **the duration of which shall be specified by the local chief executive concerned in a written order:** Provided, however, That no national or local road, alley, park, or square shall be temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Tigbauan, Province of Iloilo, in a session assembled, that:

### **Section 1. DEFINITION OF TERMS.**

1. *Motor vehicle* – any vehicle propelled by motor.
2. *Trisikad*- any vehicle propelled by muscular power having an attachment sidecar with single or double pneumatic tires for transportation of passengers or light cargoes for a fee.
3. *Big trucks* – a motor vehicle designed to transport cargo.

**Section 2. COVERAGE** – In connection with the “All Saints Day” and “All Souls Day” Celebrations, on Nov. 1 – 2, 2013, the half portion of the national highway along Barangay 7 (Poblacion) in front of the Tigbauan Catholic Cemetery shall be temporarily closed, to wit:

- a.) All vehicles **going to Iloilo** shall pass the Allera Street going to Coco Grove Beach Resort and MTC College at Brgy. Tan Pael, this municipality;
- b.) All vehicles **going to Antique** shall pass the Zulueta Drive going to the Tigbauan National High School passing the poblacion.
- c.) All **big trucks going to Antique** shall follow the usual route by passing the right lane portion of the national highway along Barangay 7 (Poblacion) in front of the Tigbauan Catholic Cemetery.


**Section 3. DURATION AND TIME.** This ordinance shall be implemented on **Nov. 1 and 2, 2016 from 7:00 o’clock in the morning to 8:00 o’clock in the evening** in connection with the “All Saints Day” and “All Souls Day” Celebration.

**Section 4. SEPARABILITY CLAUSE** – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

**Section 6. EFFECTIVITY** – This Ordinance shall take effect immediately.
