Municipal Ordinance No. 2017-015

AN ORDINANCE FOR THE TEMPORARY CLOSURE OF A PORTION OF ALLERA STREET TIGBAUAN, ILOILO FOR THE REPAIR AND REHABILITATION OF THE MUNICIPAL ROAD (IN FRONT OF PALAWAN PAWNSHOP) COVERING THE PERIOD SEPTEMBER 11, 2017 TO NOVEMBER 30, 2017

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

“Closure of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx

WHEREAS, the Department of Public Works and Highways (DPWH), thru the efforts of Congressman Richard S. Garin, has set aside a budget for the “*Concreting of 115 meters portion of Allera Street*” which will start in front of the Palawan Pawnshop;

WHEREAS, the identified street is one of the busy streets in the poblacion because it is located near/beside the Tigbauan Public Market, thus the immediate repair thereof is necessary;

WHEREAS, the improved condition of the said municipal road will not only be safe and convenient for road users, but it will also benefit the whole municipality considering that it is one of the major thoroughfares leading to the public market;

NOW, THEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

*Section 1. **COVERAGE*** – In connection with the above-mentioned purpose, the portion of Allera Street (*starting in front of Palawan Pawnshop*), Tigbauan, Iloilo, shall be temporarily closed to motor vehicles.

*Section 2. **DURATION*** – The temporary closure shall take effect on September 11, 2017 to November 30, 2017.

*Section 3. **MISCELLANEOUS PROVISIONS*** – The Punong Barangays of Poblacion 8 & Poblacion 9, Tigbauan, Iloilo with the aid of their Barangay Tanods and the Tigbauan PNP shall facilitate the implementation of this ordinance and shall maintain the peace and order of the area for the duration of the temporary closure.

*Section 4. **SEPARABILITY CLAUSE*** – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

*Section 5. **EFFECTIVITY*** – This Ordinance shall take effect immediately.
