**Municipal Ordinance No. 2017-016**

AN ORDINANCE TEMPORARILY CLOSING PORTION OF THE TOURISM ROAD AT BARANGAY NAMOCON, TIGBAUAN, ILOILO DUE TO THE DEATH AND WAKE OF THE LATE ANTONIO JABAT ARIAS

*Sponsored By:* HON. JOHN GERSHWIN C. TUERES, *Member, Committee on Barangay Affairs,*

*Seconded By:* Hon. Dennis T. Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña and Hon. Julius T. Ledesma,

WHEREAS, in order to accommodate family members, friends, and relatives who will come to pay homage to the late *Antonio Jabat Arias*, husband of former S.B. Member Loreta L Arias certain structures will be set-up outside their residence located at the Tourism Road, Barangay Namoccon, Tigbauan, Iloilo, which may hamper the free flow of traffic in the area;

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

*"Closure of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx; (c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx"*

WHEREAS, for humanitarian reasons, all the members of the Sanggunian present voted for the passage of an ordinance temporarily closing the above-mentioned road, subject to the following conditions:

- a. The Closure time shall be from 1:00 pm to 4:00am;
- b. Appropriate signages shall be placed to warn the public of such closure;
- c. Tents/roofings should be high enough to allow the free passage of vehicles during open hours.

BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

*Section 1. COVERAGE* – In connection with the above-mentioned purpose, portion of Tourism Road at Barangay Namocon, this municipality, shall be temporarily closed to motor vehicles subject to the above-enumerated conditions;

*Section 2. DURATION AND TIME* – The temporary closure shall take effect from September 18, 2017 to September 23, 2017;

*Section 3. MISCELLANEOUS PROVISIONS* – The Punong Barangay of Barangay Namocon, Tigbauan, Iloilo with the aid of its Barangay Tanods shall facilitate the implementation of this ordinance and shall maintain the peace, order and cleanliness of the area for the entire duration of this temporary closure.

*Section 4. SEPARABILITY CLAUSE.* – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

*Section 5. EFFECTIVITY.* – This Ordinance shall take effect immediately.
