Municipal Ordinance No. 2018-001

AN ORDINANCE FOR THE TEMPORARY CLOSURE OF A PORTION OF THE ROAD PASSING THE TEJERO AND ALLERA STREETS OF THIS MUNICIPALITY FOR THE FOOD FEST AND PERYA IN LINE WITH THE CELEBRATION OF THE 2018 TIGBAUAN DEVOTIONAL FIESTA OF SR. STO. NIÑO.

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

“Closure of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx

WHEREAS, the Municipality of Tigbauan will celebrate its devotional fiesta in honor of Sr. Sto. Niño on January 21, 2018;

WHEREAS, one of the highlights of said celebration is the holding of “*peryahan*” and food festival in this municipality;

WHEREAS, the LGU has identified the following portions of roads/streets within the poblacion as sites for the holding of “*peryahan*” and food festival in this municipality:

- A portion of the Tejero St., specifically at the back of the Tigbauan Municipal Building passing the Tigbauan Public Market going to Brgy. 9 (Pob.)/Sta. Lucia;

- A portion of Allera Street specifically in front of the Tigbauan Police station passing the side of the Tigbauan Public Market going to Brgy. 8 (Pob.);

NOW, THEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

Section 1. COVERAGE – In connection with the above-mentioned purpose, portions of the roads passing the Tejero and Allera Streets, Poblacion, this municipality, shall be temporarily closed to motor vehicles.

Section 2. DURATION – The temporary closure on the aforementioned streets/roads shall take effect upon approval of this ordinance from January 8, 2018 to January 20, 2018 (**5:00 p.m. to 12:00 midnight**) and on January 21, 2018 (**the whole fiesta day until noon time of January 22, 2018**);


Section 3. MISCELLANEOUS PROVISIONS – The Punong Barangays of Poblacion 8, & Poblacion 9, Tigbauan, Iloilo with the aid of their Barangay Tanods and the Tigbauan PNP shall facilitate the implementation of this ordinance and shall maintain the peace and order of the area for the entire duration of this temporary closure.

Section 4. SEPARABILITY CLAUSE – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5. EFFECTIVITY – This Ordinance shall take effect immediately.
