AN ORDINANCE RECLASSIFYING FROM AGRICULTURAL TO RESIDENTIAL VARIOUS LOTS OWNED BY ENGR. ISIDRO MINERVA AND DR. IKE MINERVA, RESPECTIVELY ALL LOCATED AT BRGY. NAMOCON, TIGBAUAN, ILOILO, PHILIPPINES.

WHEREAS, R.A. 7160, otherwise known as the Local Government Code (LGC) of 1991 provides that municipalities may reclassify agricultural lands into non-agricultural uses within their respective jurisdictions, subject to the limitations and other conditions prescribed under Section 20 of the LGC;

WHEREAS, Memorandum Circular No. 54 of the Office of the President, prescribing the guidelines governing Section 20 of R.A. No. 7160 otherwise known as the Local Government Code of 1991, authorizing cities and municipalities to reclassify agricultural lands into non-agricultural lands into other uses:

WHEREAS, as per Resolution No. 05, Series of 1995, the Municipality of Tigbauan has adopted and approved its Revised Comprehensive Development Plan (Comprehensive Land Use Plan) and it was duly approved by the Sangguniang Panlalawigan through Resolution No. 96-186-A. Hence, the subject parcels of land has been zoned for use as per approved Comprehensive Land Use/Zoning Ordinance of the Municipality of Tigbauan through S.B. Resolution No. 2015-085 and Municipal Ordinance No. 2015-004;

WHEREAS, the Implementing Rules and Regulations (IRR) of the LGC provides that cities and municipalities shall continue to prepare their respective Comprehensive Land Use Plans, enacted through Zoning Ordinances, subject to applicable laws, rules and regulations;

WHEREAS, the Municipal Development Council, approved and conformed on January 10, 2018 Resolution No. 2018-01, "Resolution Indorsing the Reclassification of Thirteen (13) Parcels of Land With the Total Area of 19,284 Square Meters More or Less, from Agricultural to Residential, Owned by Engr. Isidro Minerva and Ike Minerva Located at Barangay Namocon, Municipality of Tigbauan, Province of Iloilo";

WHEREAS, a certificate of irrigation coverage was issued by the National Irrigation Administration pursuant to Malacañang Administrative Order No. 20, series of 1992 and Department of Agrarian Reform Administrative Order No. 13, series of 1994, stating that such parcels of land has been found to be outside irrigated lands and water is not available to support rice and other crop production, issued on December 13, 1996;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF TIGBAUAN THAT:

SECTION 1. TITLE: "AN ORDINANCE RECLASSIFYING FROM AGRICULTURAL TO RESIDENTIAL VARIOUS LOTS OWNED BY ENGR. ISIDRO MINERVA AND DR. IKE MINERVA, RESPECTIVELY ALL LOCATED AT BRGY. NAMOCON, TIGBAUAN, ILOILO, PHILIPPINES".

SECTION 2. COVERAGE. This ordinance shall cover properties particularly described as follows:

SECTION 3. MANNER OF UTILIZATION AND DISPOSITION. The agricultural lands covered under Section 2 hereof shall be utilized for residential and compatible uses.

SECTION 4. UPDATE ON COMPREHENSIVE LAND USE PLAN. This ordinance shall likewise update the existing approved Comprehensive Land Use of the Municipality of Tigbauan.

SECTION 5. SEPARABILITY CLAUSE. Any provision of this ordinance which shall be declared invalid shall not affect the other provisions not so declared, which shall remain in full force and effect.

SECTION 6. EFFECTIVITY. This ordinance shall take effect fifteen (15) days after its approval and posting in three (3) conspicuous places in the municipality.
