Municipal Ordinance No. 2018-011

AN ORDINANCE TEMPORARILY CLOSING PORTION OF LEONARDIA STREET, BARANGAY 06, POBLACION, TIGBAUAN, ILOILO DUE TO THE DEATH AND WAKE OF THE LATE ESTELITA TRIÑO.

WHEREAS, in order to accommodate family members, friends, and relatives who will come to pay homage to the late Estelita Triño, certain structures will be set-up outside their residence on portion of Leonardia Street, Barangay 6, Poblacion, Tigbauan, Iloilo which may hamper the free flow of traffic in the area;

WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

“Closure of Roads – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx; (c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx”

WHEREAS, for humanitarian reasons, the Sanggunian unanimously voted for the passage of an ordinance temporarily closing the above-mentioned road, subject to the following conditions:

- The Closure time shall be from 1:00 pm to 4:00am;
- Appropriate signages shall be placed to warn the public of such closure;
- Tents/roofings should be high enough to allow the free passage of vehicles during open hours.

NOW, THEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan, that:

Section 1. COVERAGE – In connection with the above-mentioned purpose, portion of Leonardia Street, Barangay 6, Poblacion, this municipality, shall be temporarily closed to motor vehicles subject to the above-enumerated conditions;

Section 2. DURATION AND TIME – The temporary closure shall take effect from November 22, 2018 to December 8, 2018;

Section 3. MISCELLANEOUS PROVISIONS – The Punong Barangay of Barangay 6, Poblacion, Tigbauan, Iloilo with the aid of its Barangay Tanods shall facilitate the implementation of this ordinance and shall maintain the peace, order and cleanliness of the area for the entire duration of this temporary closure.

Section 4. SEPARABILITY CLAUSE. – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5. EFFECTIVITY. – This Ordinance shall take effect immediately.
