**Municipal Ordinance No. 2020-005**

AN ORDINANCE SUSPENDING THE PROVISIONS OF MUNICIPAL ORDINANCE NO. 2010-007 ON THE COLLECTION OF STALL RENTALS AT THE TIGBAUAN PUBLIC MARKET DUE TO COVID-19 PANDEMIC.

WHEREAS, on September 1, 2010 the August Body passed Municipal Ordinance No. 2010-007 entitled: "AN ORDINANCE IMPOSING LEASEHOLD RIGHTS DEPOSIT AND MONTHLY RENTAL FEES ON PHASE 1 AND 2 OF THE NEWLY-CONSTRUCTED TIGBAUAN PUBLIC MARKET;"

WHEREAS, Section 8 of said Ordinance states, "SECTION 8. RENTAL The municipality shall execute a contract of lease which shall stipulate the specific terms and conditions of the leasehold. The municipality shall impose a rental fee which shall be payable every 30th day of the month, subject to a five percent (5%) increase every two (2) years, to wit:

PHASE 1: P 3,000.00/month

PHASE 2: P 2,000.00/month;"

WHEREAS, Proclamation No. 922 was issued on March 8, 2020 by the President of the Philippines, entitled: "Declaring a State of Public Health Emergency Throughout the Philippines;"

WHEREAS, Proclamation No. 929 was issued on March 16, 2020 by the President of the Philippines, entitled: *"Declaring A State Of Calamity Throughout The Philippines Due To Corona Virus Disease 2019"* for a period of six (6) months, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, Executive Order No. 028-C, S. 2020 was likewise issued on March 10, 2020 by the Iloilo Provincial Governor, Hon. Arthur Defensor, Jr., entitled: *"An Order Further Strengthening the Imposition of Quarantine Procedures and Disease Prevention and Control Measures To Protect the Province of Iloilo Against the Corona Virus Disease 2019 (COVID-2019);"*

WHEREAS, because of this extra-ordinary situation, the members of this August Body, pursuant to the letter request of the good Mayor, decided on consensus to suspend the provisions of Municipal Ordinance No. 2010-007 on the collection of stall rentals at the Tigbauan Public Market due to COVID-19 pandemic;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN IN SESSION ASSEMBLED:

SECTION 1. This shall be known as, *"AN ORDINANCE SUSPENDING THE PROVISIONS OF MUNICIPAL ORDINANCE NO. 2010-007 ON THE COLLECTION OF STALL RENTALS AT THE TIGBAUAN PUBLIC MARKET DUE TO COVID-19 PANDEMIC."*


SECTION 2. Due to the decrease in income of the Tigbauan Public Market stall occupants, the Municipal Government has decided to suspend the provisions of Municipal Ordinance No. 2010-007 on the collection of stall rentals for the months of March and April 2020.

SECTION 3. SEPARABILITY CLAUSE. If any provision of this ordinance be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately.
