**Municipal Ordinance No. 2020-007**

AN ORDINANCE SUSPENDING THE PROVISIONS OF THE TRANSPORTATION AND TRAFFIC CODE RELATIVE TO FARE RATE OF TRICYCLES AND ALLOWING AN ADDITIONAL ₱5.00 TO THE APPROVED REGULAR FARE UNTIL REVOKED.

WHEREAS, on March 11, 2020, the August Body passed Municipal Ordinance No. 2020-001 entitled: *"Enacting The Transportation And Traffic Code Of The Municipality Of Tigbauan, Province Of Iloilo And Providing Penalties For Violations Thereof"*;

WHEREAS, Chapter XXIII of the said Code regulates/prescribes fare rates for tricycles, pedicabs and e-trikes for hire operating in the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, Proclamation No. 922 was issued on March 8, 2020 by the President of the Philippines entitled, *"Declaring a State of Public Health Emergency throughout the Philippines"*;

WHEREAS, Proclamation No. 929 was likewise issued by the President of the Philippines on March 16, 2020 entitled, *"Declaring A State of Calamity Throughout the Philippines Due to Corona Virus Disease 2019"* for a period of six (6) months, unless earlier lifted or extended as circumstances may warrant;

WHEREAS on March 10, 2020, the Iloilo Provincial Governor, Hon. Arthur Defensor Jr., issued Executive Order No.028-C, S.2020 entitled, "An Order Further Strengthening the Imposition of Quarantine Procedures and Disease Prevention and Control Measures To Protect the Province of Iloilo Against the Corona Virus Disease 2019 (COVID-2019)";

WHEREAS, Hon. Arthur Defensor Jr., Governor Province of Iloilo further issued on May 15, 2020 Executive Order No. 118, series of 2020 entitled: "An Order Enforcing General Community Quarantine Over The Entire Province Of Iloilo To Sustain Quarantine Procedures And Disease Prevention And Control Measures Against The Corona Virus Disease 2019";

WHEREAS, the Hon. Mayor, Atty. Suzette Tenefrancia- Alquisada, of the Municipality of Tigbauan, Province of Iloilo issued Executive Order No.2020-37 dated May 2020 entitled: "An Order Enforcing A General Community Quarantine From May 16, 2020 Until May 31, 2020 To Sustain Quarantine Procedures And Disease Prevention And Control Measures Against The Corona Virus Disease 2019 (COVID-19)";

WHEREAS, because of this situation and developments, the members of this August Body, pursuant to the letter request of the good Mayor, decided on consensus to suspend the provisions of Municipal Ordinance No. 2020-001, *Transportation and Traffic Code* relative to fare rate of tricycles, and allowing an additional of P5.00 on top of the regular fare until revoked.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN IN SESSION ASSEMBLED:

**SECTION 1.** This shall be known as, " *AN ORDINANCE SUSPENDING THE PROVISIONS OF TRANSPORTATION AND TRAFFIC CODE RELATIVE TO FARE RATE OF TRICYCLES AND ALLOWING AN ADDITIONAL OF P5.00 TO THE APPROVED REGULAR FARE UNTIL REVOKED.*

**SECTION 2.** The Imposition of the ODD-EVEN Scheme for tricycles for hire and allowing three (3) passengers only per trip caused the decrease of income of drivers, for which the Municipal Government decided to suspend the provisions of the Municipal Ordinance No.2020-001, relative to fare rate of tricycles and allowing an additional of P5.00 to the approved regular fare until revoked.

**SECTION 3. SEPARABILITY CLAUSE.** If any provision of this ordinance be declared null and void, unconstitutional or in conflict with the existing laws, ordinances, other parts not affected thereby shall remain valid and enforceable.

**SECTION 4. EFFECTIVITY CLAUSE.** This ordinance shall take effect immediately.
